### **LEGISLATION**

#### **AMEND CHAPTER 193 – COMPLY WITH OHIO SB 172 – RETIRED CITIZENS**

**BY: MR. VAN HARLINGEN**

**ORDINANCE 16-211**

Amending portions of Chapter 193 of the Codified Ordinance of the City of Mansfield regarding municipal income tax to ensure compliance with Ohio SB 172 and enacting portions of Chapter 193 to allow for certain exemptions for retired citizens of Mansfield, and declaring an emergency.

Upon motion by Mr. Van Harlingen that Bill 16-213 be read and placed upon the floor for discussion, seconded by Mr. Rock.. The bill was placed upon the floor for final passage, seconded by Mr. Rock..
