PUBLIC HEARING – DESIGNATING 159 N WALNUT ST AS HISTORIC

STEVE MCOUILLIN: I'm the new owner of 159 N. Walnut St., the A.G Hedrick's house. I bought the place from Grant Milliron and I bought it with the intent of rehabilitating it and I'm in the midst of applying for a State of Ohio Preservation Tax Credit to help with the funding on it and in order to do that it has to be a local landmark, so I need your approval of the request for local landmark status in order to be successful with that application, that would be great. I plan to spend a good deal of money renovating it, I'd like to make it into two living units, once which could be an older suite at some point and then a little loft apartment at the back. The building is a wonderful building, I've had a lot of good comments from people and everything. I was out doing some work there yesterday and people stop by and say, Hey, what's going on, what's happening, everything like that so it's good. It's a highly visible building, it's sort of one of the last links in the downtown area there and I know it's been a policy of the Man St. and others to see that building renovated so I'd like to be able to move forward, but without the help of this program, it would be difficult to do the things that need to be done. It has a wonderful barch board trim and there's a lot of it that's missing or deteriorated, that needs some work, the brick needs some work. The inside has some real nice woodwork, but it needs a lot of work too. It hasn't been lived in for about 50 years, so this would help. I've also, hoping to ask the city for a letter of support and if I get any kind of funding support I get 3 more points on my application so I'm going to be doing that by the end of this month. Does anyone have any questions? Oh by the way, about me, I renovated what was called the Vermillion Institute in Hayesville and that's where my home and office is. I've also applied for, and received, the state tax credit for the renovation of the Kelly Hardware building in Hayesville and I want to make that into apartments too, so I work as a preservation consultant, a lot of my work is out of state but I kind of know the ins and out of this complicated application process, so that's why I'd like to do it. So far, everything's moving along with the deadlines and this is my last big hurdle through you so I'd appreciate your approval on the landmark's application.

PRESIDENT SCOTT: I think it's a great effort. I've seen that house for a long time and I've thought someone needs to take care of it while it still can be taken care of. Briefly, what's the history on the Hedrick house?

MR. MCQUILLIN: It was built around 1860 and Hedrick, I was just reading about him today, he was born 1814, he came from Maryland with his parents very early in the city's history, then took off for California during the gold rush of 1849, settled in Idaho for a while, Mississippi, then was a farmer for years in Richland County then operated the Hedrick and Houston Meat Market downtown on the square and then was at least alive by the time of Graham's history in 1880's, but fairly prominent and we also think that it may have had a similar design or kind of inspired by Oak Hill Cottage because that and Oak Hill are the only two brick buildings of that particular style, so I've gotten a lot of comments on social media, people say it looks like a doll house or it looks great or that type of thing. So, and one other thing is, I need your final approval at this meeting, if you don't mind, because the state application deadline is the 29th of September and it's got to be certified by your Council Clerk as a landmark by that time.

PRESIDENT SCOTT: Well we do have that piece of legislation, it's Bill 17-156 sponsored by Mr. Van Harlingen and it's up for a vote tonight.

MR. MCQUILLIN: That's wonderful, I really appreciate it.

MR. VAN HARLINGEN: I'd just like to make one quick comment. I've never met Mr. McQuillin, but in his spiel, his historic preservation and what have you, the folks in this area think very, very highly of him, he has accomplished many projects in the past that have been mentioned in meetings and thank you sir, for taking an interest in our town.

MR. MCQUILLIN: Thank you. It'll be a nice challenge to do. I do not want it to sit idle and that's why I want to get on it soon.

MR. BRYANT: Doesn't that house have some sort of (inaudible).

MR. MCQUILLIN: There's another house that's in the land bank at First and Wood and that needs a lot of work too. Thank you. Next I'll be on to the Mayor and asking him for that letter of support.
