**Subject: Search Warrant Served** 

On February 24, 2016 the METRICH Enforcement Unit assisted by the Mansfield Police Department served a search warrant at 57 Brickman Avenue.

Detectives from the METRICH Enforcement Unit went to the Brickman Avenue residence after receiving complaints of drug trafficking. While at the home, the detectives gathered information to establish probable cause for a search warrant. This search warrant was reviewed and signed by the Honorable Judge Ault.

Detectives from the METRICH Enforcement Unit searched the residence and located (3) firearms; a .380 Bersa, a 556 FMK AR-15 and a 44 Ruger. Detectives also located 59 grams of cocaine and digital scales.

Terrence Sudberry and Martell Seals were arrested. Both men are originally from Detroit Michigan.

Lt. Stortz thanks community members that continue to reach out to local Law Enforcement and report drug activity in their neighborhoods. This continued effort will make our community a safer place to live.
