

## **REGULAR COUNCIL MEETING February 4, 2020**

The First monthly meeting of Mansfield City Council met on Tuesday,  
February 4, 2020 at 7:00 PM in the Council Chambers of the City Building.

The Pledge of Allegiance was recited by the audience.

Councilman Lawrence led the audience in prayer.

**ROLL CALL:** The following answered present at roll call: Burns, Meier, Van Harlingen, Davenport, Lawrence, Taddie, Scott, Falquette, and Mears.

There being no objections, the reading of the Journal and Correspondence was dispensed with.

### **Public Comments:**

**PRESIDENT MEARS :** We have four individuals signed up to speak tonight. The first is Mr. Beatty. If you would come to the microphone, please, Sir and give us your name and address. Good to see you again.

**ROBERT BEATTY:** Thank you. Same here. My name is Robert Beatty I live at 1099 Walker St, Mansfield, Ohio. Um. I had fliers passed out to everybody. Um, one of the things that concerned is, for myself is the trash and tires that is scattered throughout Mansfield. Um, I believe that we should be makin' the landlord, homeowners, and renters more accountable for these issues that are all over. Example on this paper here is on Delf Avenue and this is the property that lies between the trailer park over by Longview and Roseland. And so it's kinda like who, people are going back there and they are throwing all this garbage back there. Who actually is liable for that? Be, uh, whether the trailer court or whether it's decision Mansfield? Um, I've delt with the trailer court before and, unfortunately, we're not allowed to be on the property because, it's privately owned. We can't do anything. Um, as far as you know um, I took these pictures yesterday and you know it's kinda like okay, who's actually going to be able to pick up all these tv's and dispose of them and everything? The tires? You know, there is a issue there. I know that we do know that we do have a drop off once a year. Um, wasn't sure if it was in the City budget to maybe do another drop off, or maybe make the tenants or the people with the tires pay for it, you know? Uh, with the Codes and everything. But I will say this here, because I know that I have a short time. Uh. I had, the past couple weeks I had, uh, I had an issue with the landlord who owns a lot of property in Mansfield. And um, uh, I got with the City and we need to force him to start cleaning up his mess. Um, he's beena round a very long time, as well as other landlords. Um, but after speaking with him, uh, he is starting to clean up and I'm really glad about that because it affects our area, and I'm sure that each Council in every single Ward, you know, had those issues going on. And, um, so, as far as the garbage and everything, we...we

have clean-ups once a year, or twice a year possibly, but what so we do with situations like this right here when you don't have the necessity to go ahead and go around and pick all this stuff up? So, is it possible that the City maybe has the funds to hire somebody to go around and pick up all this stuff, you know instead of sitting there and waiting for it to gather more? Um, you know, is there anyway, you know that ,uh, we have buildings, we have, you know have old shacks, um, that need to be tore down and, it's on their property. The bottom line is this, the landlords and everybody, they need to be held accountable for it. And I believe, my opinion, we haven't enforced it enough. Because, when it's enforced somebody's gonna do something about it especially if it's gonna come out of their pocket. No if, and, or buts about it. And so an example that I just explained about the one landlord, I'm real happy about it, but there's a lot more work to be done with these landlords and everybody. The people you know, several people behind me, from our area, they have went ahead and we've got, like I said we've got some problems. One of the quick issues before I finish here is, I'm really bothered that ,um when we have someone that has issues, health wise, mental wise, whatever, and they own property, when the City goes head and writes the violations or sends them a letter because they have to go to court...they go to court they spend three, five days in jail and then they're back out again. But they're still doing the same thing, but then you find out that the law director does not want to do anything about it, because they're not going to get anything out of them anyways. So, where do we lie with some of these people? You know, that part I cannot give an answer or thought of what could be done.

**PRESIDENT MEARS:** I'm afraid I have to ask you to wrap it up Mr. Beatty.

**MR, BEATTY:** Oh, okay.

**DIRECTOR SPON:** May I respond or make an inquiry?

**PRESIDENT MEARS:** Sure, Law Director.

**DIRECTOR SPON:** I, I'm not sure that I understand your statement that the Law Director, I'm the Law Director, and your statement is, I "don't want to do anything about it." Quite to the contrary. When this issue of rubbish had come up, by either yourself or somebody else at our last meeting I kicked into motion a review of all of our Ordinances. Some of which are very old and need updated.

**ROBERT BEATTY:** Umhm.

**DIRECTOR SPON:** Some of our Ordinances dealing with rubbish refer, even to the sanitation department of the city which no longer exists. So. I'm all for cleaning up the Community and I've set into motion to first look at our Laws, to modernize them, to update them, and then to make them practically enforceable. The other side of it is, in answer to your question, who picks up the trash. The ultimate responsibility, technically, on paper, is with our Codes and Permits, but they're we're very limited on man power in terms of making it available to pick up various areas of trash, so what we're doing is inviting the public that when you see any neighbors,

leaving out just trash bags, that aren't in cans, to report that, to Codes and Permits, and if you can take a photograph with your phone to identify the person, and or address where it's located, we will issue citations and we will prosecute. So, I wanted you to know.

**ROBERT BEATTY:** Well, I could give you the address.

**DIRECTOR SPON:** The greatest help we can have is with the citizens themselves reporting it; and if they report it and give us adequate amount of information we can respond. And so we would respectfully ask that and wanted to make sure that you know that I'm probably the most anti-rubbish Law Director in the State of Ohio. (Chuckles around room). Okay. Thank you very much.

**ROBERT BEATTY:** Okay. Thank you very much, then.

**PRESIDENT MEARS:** Thank you, Law Director Spon. Thank you Mr. Beatty. Thank you.

**JASON LAWRENCE:** Wow.

**JEAN TADDIE:** Mr. President if I could just comment that, that issue is one of the most common issues that I get calls for from my constituents. Garbage, litter, tires. On private property, on vacant property, and even on just wood lots around the city, so we thank every and all attempt not only by Law Director, but by Community Police and the Police as a whole to help us address this.

**PRESIDENT MEARS:** Thank you Councilwoman Taddie. Any other comments on this issue? Okay, thank you very much. The next speaker is Kathleene Boyle. Would you come to the microphone and state your name and address please?

**MS. BOYLE:** I'm Katleene Boyle, I'm here to speak up about a Community Center or a even a Pavilion at Liberty Park. Liberty Park has a building has a building that's all boarded up, that if ODOT came out there it would need to be tore down. There's Pride Tax money going to privately owned houses, why not a public park? The other Parks in Mansfield, a lot of them, have nice pavilions. We have nothing on East End of Mansfield, at Liberty Park. People on the East end pay taxes just like the people on the North end, and on the south end. We deserve a meeting place for people and our Seniors to be able to meet and have a good time. Um, anyway, our local government; you guys are our decision makers, you guys decide how to spend the money. And in most every instance that I've been listening to in the last couple of months, and I've been coming to, I have no objections, other than the fact, I see things that are happening for kids and teenagers; let's add something to those, let's make it a little more diversified to twenty percent of the population of Mansfield, which are Seniors. I think it's about time that Liberty Park gets out on the demolition list. That could be a first step. It is boarded up and it does not look structurally; I went over by there today and the walls are caving a little bit on the ssi,.. On the, on where people have picnics, underneath that building. A child might get up in there. Uh, however, we just had a kid die from going down a chimney, I'm sure a child could get up in there and get stuck, that, that needs to be torn down. It's an eye sore. In East center Mansfield, we have a

beautiful hospital new hospital, University Hospital, gonna be opening up here in a couple weeks, that would be something that would add to the East End of Mansfield. And, uh, monies, expenditures, two hundred twenty-nine thousand dollars for playground equipment for two parks. I'd say a hundred thousand for a nice pavilion at Liberty Park should be fair. Even if it's a pole barn, it doesn't have to be anything fancy, just so long as people can get together and have a good time. And expenditures that I'm seeing and the two hundred and the twenty-nine thousand and I know that you guys aren't spending a lot of this money, but I'm seeing a fancy meals and fancy banquets and stuff going on. Chamber of Commerce and Regional Planning, uh, why not have a pot-luck? That's what everybody else does. I worked at Child support ten years and made under ten dollars an hour, that was almost twenty years ago. We never had a fancy white tablecloth meal. We brought in our own food, so if Mansfield doesn't have the money for somethings they shouldn't have them for others. Nobody is any better than anybody in this town or anywhere else.

**ADUIENCE:** That's right.

**MRS. BOYLE:** Thank you.

(Some clapping)

**PRESIDENT MEARS:** Thank you Mrs. Boyle. The next speaker, third out of four is Damone Shoulders. Please come to the microphone and state your name and address, Sir. Thank you.

**DAMONE SHOULDERS:** Good evening, I'm Damone Shoulders. My address is 523 Straub Road West. I'm here to address Council about, for in behalf of Culliver Reading Center. Um, we recently received um, a non-renewal notice. And um, the um, the Ocie Hill builing and I want to um, that our being in the community and what we do in the community, is important. Uh, for Mansfield and the County. Uh, we deal with children throughout the County. We average, during the year, through the reading service, approximately a hundred kids a year. Okay, and weve been doing that for the past twenty-eight years. Our graduates, if you will, are Doctors, Lawyers, Actors, Actresses, uh, productive citizens. Uh, we have military people in our repertoire of graduates. and what we do, I think, fosters good citizenship and our being in the North End and where we are is beneficial for the City of Mansfield and I would like for um, Council to re-think that decision for that non-renewal.

**PRESIDENT MEARS:** Thank you , Sir. You said, you got a non-renewal notice...

**DAMONE SHOULDERS:** Yes.

**PRESIDENT MEARS:** ... for Ocie Hill building?

**DAMONE SHOULDERS:** Yes.

**PRESIDENT MEARS:** Mr. Abrams since you're here, if I could address that now; is that something that comes under your area?

**MARK ABRAMS (PARKS):** It does. Yes.

**PRESIDENT MEARS:** Is it anything that you can address at this time?

**MARK ABRAMS:** I would rather not delve into it in a public setting. There are some issues that we need to work to resolve with Culliver...

**PRESIDENT MEARS:** Okay. So, perhaps Mr. Shoulders and you can meet separately and...

**MARK ABRAMS:** I believe that Mr. Davenport and the Mayor have discussed this issue and I believe that it will be resolved shortly.

**PPRESIDENT MEARS:** Okay. Thank you for coming, Sir. Our last speaker is Christina O'Million....Yes, Sir.

**ALOMAR DAVENPORT:** I just want to make note that I am very aware of the situation there at Ocie Hill and as was just stated there, I have been speaking to the Mayor and the Administration in regard to it, um, some of the citizens wanted to come in and um, express their concern for what was going on. Um, we have come to an agreement to what's going on in, principle. As Mr. Abrams did say, there are some issues that need to be worked out over the next couple of weeks, but we do feel that we will be able to resolve this issue, um and, and be begin, continue to move forward and allow those non-profits there to continue to service the community. Service the, the uh, citizens that they are, uh, servicing and continue to move forward.

**PRESIDENT MEARS:** Thank you, Mr. Davenport. I appreciate that. ...And now...O'Million?

**CHRISTINA O'MILLION:** Yes. My name is Christina O'Million. My address is 116 Elmridge Road Apartment #1 Mansfield. Um, the issue that I was here, is the similar issue with Ocie Hill, but we still wanted to make our public statement about the issue. I'm here as a board member on behalf of Mansfield Gay-Pride Association. We currently rent two spaces from the City at the Ocie Hill building. One that we use as Board Office and meeting space and the second that we use as our community room and support group space. Um, I am here to speak in regards of the letter that we received, as well. Um state, on January 29<sup>th</sup>, stating that the Parks Department decided not to renew our lease with us, um and that we were set to expire in March. Mansfield Gay-Pride Association is in our sixth year as a local organization to provide services and support to local LGBTQ+ Community. We partner with other local community organizations, like children's services, the Alzheimer's Association, and the Richland Outreach Center. We do utilize public spaces when we can, like monthly meet and greets. We have by-monthly lunches with pastors. We rent spaces for our LGBTQ Prom and our Masquerade Ball Fundraiser. And of course we use the downtown space for our Pride Parade and festival. Since acquiring our office space at Ocie Hill, we have been able to provide three different monthly support groups to our Community. We have added and expanded; Education Resource Library and we offer a safe space for our LGBTQ+ Community to utilize during our daily office hours. The importance of being able to have an affordable space of our own, has been able, has been crucial for us to be able to expand and offer ongoing regular services to our Community. Since

receiving this letter we have been working, as a Board, to reach out to all contact we know, to try to find a comparable space in a short amount of time, with our limited non-profit budget. And we just wanted to come here today to express our appreciation to the City for our relationship with the City and we would like to ask that you consider renewing our lease at Ocie Hill, which I understand is something in the works now. (chuckle) And thank you.

**PRESIDENT MEARS:** Thank you for coming.

**JEAN TADDIE:** Mr. Mears.

**PRESIDENT MEARS:** Yes. Ms. Taddie. Would Mr. Abrams or the Mayor like to comment on, on what is our vision for that building going forward? It seems odd that we sent these letters out even with a change of heart; are we planning on continuing this as a Community Center?

**MAYOR THEAKER:** Well, we're previewing all the facts right now.
