

REGULAR COUNCIL MEETING
May 19, 2020

The Second monthly meeting of Mansfield City Council met on Tuesday,
May 19, 2020 at 7:00 PM via Zoom Meeting,
due to COVID-19 pandemic

The Pledge of Allegiance was recited by the audience.

Councilman Lawrence led the audience in prayer.

ROLL CALL: The following answered present at roll call, via Zoom: Burns, Meier, Van Harlingen (in Chambers), Davenport, Lawrence, Taddie, Scott, Falquette, and Mears.

There being no objections, the reading of the Journal and Correspondence was dispensed with.

Public Comments:

NOTE: All emails are currently being ready proxy by Ward Council Members due to COVID-19 requirements.

PRESIDENT MEARS: At this point were at the Public Comment Section. I know Councilman Lawrence, you received a public comment, did you want to reference that?

JASON LAWRENCE: I did receive a public comment from a Jeremy Jaquin. Did everyone receive that? I forwarded that on. If everyone received it and no one has any issue, I will not read it. It was a very lengthy email and so, yeah, if no one has any opposition... we've all read it.

PRESIDENT MEARS: Thank you Councilman Lawrence. Have any other Council People received anything from residents to come into Public Comment section right now; anything you want to reference or read? Okay.

JON VAN HARLINGEN: If I could just make a comment Mr. President?

PRESIDENT MEARS: Yes, Sir, Councilman Van Harlingen.

JON VANHARLINGEN: Seeing the email that was referenced and some others, by Mr. Lawrence, but particular... this one in particular... when I read these emails, you get an email address; I would really appreciate the general public, as we expect in public, your name, your address; the full address of where you live instead of an email. Cause when, until I came into Council tonight I had no idea that this gentleman was a Citizen of Mansfield. He said he was. I don't know who he is. So, for future reference, if the emails would include the Citizen's address, I know I would appreciate it.

PRESIDENT MEARS: No. You're absolutely right Councilman Van Harlingen, it needs to include an address. Good point. Good point.

JON VAN HARLINGEN: Thank you.

JASON LAWRENCE: President Mears. I did receive, I don't know if we all did, there's a question on Facebook. Amy sent it out to us.

PRESIDENT MEARS: I didn't see it. I don't see anything in my chat...

CHERYL MEIER: Go ahead Jason.

JASON LAWRENCE: It was from Aubrey Lynne. She says, "My question is, what exactly is the plan for our Safety Services? This Fire Department is not an issue I want to address, but here we are again, no safety." That was from Facebook tonight.

PRESIDENT MEARS: Do we have an address for this individual?

JASON LAWRENCE: It did not have an address with it. Maybe Miss Yockey has one, but there was no address with that. Just a name.

PRESIDENT MEARS: I see. Okay. Councilman Van Harlingen's point as a reminder, yes, we really do need to have a resident's address. As a reminder, again, Public Comment is not a requirement, but rather a courtesy to the public, so I think we really do need to insist that they have an address with their comments, so we can confirm that they are a resident of the City and consider their comments accordingly. Okay Let's move on. Are there any Committee Reports for Council?

LAURA BURNS: Mr. Mears, I did just want to mention that Amy does have the address for the Facebook commenter. She just didn't want to post it on Facebook for the world to see. Moving on

PRESIDENT MEARS: Ah, good point.

JON VAN HARLINGEN: Mr. President can I make one quick comment?

PRESIDENT MEARS: Absolutely.

JON VAN HARLINGEN: I can appreciate what Councilwoman Burns had just said about not putting an address out on face book, but if you come before Council in a normal session, we have the News media here and you are required to give your name and address and that is public information.

PRESIDENT MEARS: You're absolutely right.

JON VAN HARLINGEN: I just don't want to, I just didn't want to start a debate here, but that is public information if you address Council.

PRESIDENT MEARS: Okay, so, Councilman Lawrence I believe you've seen this Facebook Comment and we do have an address, and as Councilman Van Harlingen indicated that is something that will be Public Record, if we're willing to share that address, if the comment is not too lengthy, I think we can go ahead and do that.

JASON LAWRENCE: Again, I did read it. I'm sorry, Mr. President, I did read it. Sorry, did you not hear me?

PRESIDENT MEARS: Was that all there was to it?

JASON LAWRENCE: Yes. That's all there was to it. It was a Facebook question and she did give her name; Aubrey Layne and I didn't see an address, but apparently Amy does have an address and did not want to put it out there, but I agree with Councilman Van Harlingen that if you do come and address us, in alive setting, you are going to...we ask that you give your address, so...and again if you want me to re-read the question I will.

DAVID FALQUETTE: Mr. President?

JASON LAWRENCE: Go ahead.

DAVID FALQUETTE: I think, is it possible, that they were talking about the previous lengthy letter, that we did not think we had an address for?

PRESIDENT MEARS: No, I believe that this was a different comment. Is that correct, Mr. Lawrence?

JASON LAWRENCE: Right.

PRESIDENT MEARS: Is this the comment by Audrey Lynne at 65 Stymens?

JASON LAWRENCE: Yes.

PRESIDENT MEARS: If you would re-read that comment I would appreciate it.

PRESIDENT MEARS: I do as well. We do public email address for which Public Comments are to be directed., and we really should reference those and those alone, with an address. Point well taken.


