The City of Mansfield, Ohio, Director of Human Resources announces the opening of the following position in the **CLEARFORK RESERVOIR DIVISION:**

GENERAL STATEMENT OF DUTIES:

Under supervision from management, patrols the reservoir area; provides assistance to park visitors; Enforces laws and regulations pertaining to the reservoir; assists with equipment and area maintenance. Performs related duties.

EXAMPLES OF WORK (ILLUSTRATIVE ONLY):

Patrols the Entire Park and water area in patrol car, boat or on foot;
Investigates complaints, criminal offenses, enforces laws, ordinances, rules and regulations, apprehends violators, makes necessary arrests;
Directs pedestrian and motorized traffic;
Informs the public of park facilities, exhibits, routes and accommodations; administers first aid (when necessary);
Conducts searches for lost individuals;
Operates a variety of heavy equipment as required;
Operates and maintains equipment;
Performs overall park maintenance;
Performs related duties.

DESIRED KNOWLEDGE, SKILLS AND ABILITIES:

Knowledge of (1) security and law enforcement safety practices, procedures and techniques, (2) basic first aid techniques, (3) reservoir area geography, (4) public relations; skills in (5) operation of patrol and police equipment; ability to (6) react quickly and calmly in emergency conditions, (7) demonstrates physical fitness and agility, (8) carry out oral and written instructions, (9) communicate effectively and firmly with public.

ACCEPTABLE EXPERIENCE AND TRAINING:

Completion of a standard high school course (or G.E.D. in lieu of diploma) and law enforcement and equipment operation experience; or any combination of experience and training which provides the desired knowledge, skills and abilities.
