

REGULAR COUNCIL MEETING
August 3, 2021

The second monthly meeting of Mansfield City Council met on
Tuesday, August 3, 2021 at 8:29 PM in the
Council Chambers of the City Building.

The Pledge of Allegiance was recited by the audience.

Councilman Lawrence led the audience in prayer.

ROLL CALL: The following answered present at roll call: Meier, Burns, Van Harlingen, Davenport, Lawrence, Moton, Scott, Zader and Falquette.

There being no objections, the reading of the Journal and Correspondence was dispensed with.

PUBLIC COMMENTS

PRESIDENT PRO-TEMP SCOTT: Do we have anyone signed up to speak?

AMY YOCKEY: Deborah

PRESIDENT PRO-TEMP SCOTT: Deborah. You can come on up Deborah.

DEBORAH MOUNT: Deborah Mount 114 Cliffbrook Drive. I have two things I wanted to mention. First on bill 155, as long as the safeguards are in place that only the department head can request the transfer and it must be approved up the change of command. And the finance director does not have power to move money at will. Then I find it to be a tolerable piece of legislation. I still would like to know how the safety fund, when the chiefs work very hard to be frugal within their budget, how the money disappears from what they had available at the end of the year. I still have not been given an answer and I'm still concerned about the outcome of what happens to restricted levy dollars. So, I'd still like an answer on that. And I'm hoping that this city will come up with a means of verifying how this happens.

Secondly on the dry dam project. First...I wanted to agree with what Mr. Falquette said. If we failed to have the project ready, I don't foresee that the federal government is going to fund this. If we fail to have a project ready, I don't think any private company is going to help fund it. So, if we sit here and do nothing, I don't think were going to get funds for it. Secondly, you've raised our rates 100% approximately by what you said, we expect something for that. We're not paying extra for no reason. For us to see us, we pay those rates it sits in the funds. There's a very large sum in that fund. It's sitting there, and were not getting what were paying for. So, we have the money in the account as its been said, even with the emergency project. Which I'll also point out we have a rainy-day fund to cover emergencies. Thankfully we have a bunch of extra money in that fund so it can cover its own emergency. But we also have another place to go if there is an emergency and that is what that fund was intended.

Also, as of the last report online that's been posted, which was the end of May. The city has a positive carry over balance of \$86 Million. That's when we have a budget of \$198 million. That is not a small sum. Soo just wanted to remind you that were not broke, were not out of money. There is a lot of money sitting there that we, the citizens, are paying in our tax dollars, our water sewer bills, were paying by many means and its quite frustrating to see the city just horde the money and not spend it on the necessary projects that we, the citizens, need. So, I ask you to please take that into account. Were defiantly not broke if you look at the figures, there's a lot of money there. This is a very small sum to progress to the level of asking the federal government for help and asking private entities for help. To help this north end project. Also, revenues are way up from what was predicted. Revenues are substantially up, so that is looking good

toward the future. I know I for one, and pretty much every body I know, have worked a lot of extra hours. So, the city's going to reap the benefit of that. There's a lot of extra money coming in. So just please take into account that you raised our rates 100%, we want something for that money. Thank you.

PRESIDENT PRO-TEMP SCOTT: We have no one else signed up? Ok with that are there any committee reports? Once again, acting Mayor, President Falquette?

COUNCIL MEMBERS: Second

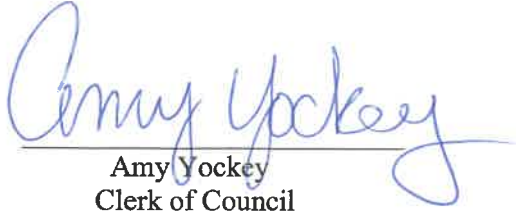
PRESIDENT PRO-TEMP SCOTT: It's been moved and seconded we adjourn. All those in favor?

COUNCIL MEMBERS: Aye

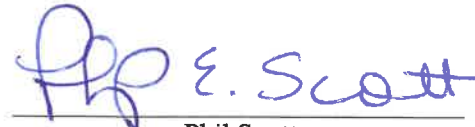
PRESIDENT PRO-TEMP SCOTT: Opposed? We are adjourned.
