

REGULAR COUNCIL MEETING February 18, 2020

The First monthly meeting of Mansfield City Council met on Tuesday, February 18, 2020 at 7:50 PM in the Council Chambers of the City Building.

The Pledge of Allegiance was recited by the audience.

Councilman Lawrence led the audience in prayer.

ROLL CALL: The following answered present at roll call: Burns, Meier, Van Harlingen, Davenport, Lawrence, Taddie, Scott, Falquette, and Mears.

There being no objections, the reading of the Journal and Correspondence was dispensed with.

ADMINISTRATION:

MAYOR: I just have a proclamation for Rev. Lintern, if I may?

PRESIDENT MEARS: Okay. Certainly, let's proceed with the proclamation.

MAYOR: If you would come on up? Reverend Lintern and Reverend Al have put together a March To be In The Prayer program, and that they have set up and in fact there's a hand out that everybody got and they've set up a prayer at different churches for the whole month of March, up to Easter and I think that's a great thing. This is the second year...(inaudible) In that I have a proclamation. Mansfield was known as a City of churches during a time when church steeples dominated the downtown skyline. Forty-Seven local Christian Churches represent more than twenty-five denominations; each hosting night of prayer, beginning March first two thousand twenty...nineteen?

REVEREND LINTERN: Well Nineteen was last year. That's how it was last year.

MAYOR: Oh., okay. And continuing until Easter and praying for local Officials, First Responders, those dealing with addictions and general welfare. Mansfield is God's field, was a common theme throughout the March of Prayer. Churches in Lexington, Bellville, Ontario, and Lucas were also hosts of these Church services. Psalms 118:19 declares: "Swinging wide the City gates, the religious gates, I'll walk right through and thank God." And I therefore, Tim Theaker, the Mayor of the City of Mansfield, let it be resolved that March of Prayer be encouraged for churches of all faiths during this month, intentionally to lift up in prayer this community, our Officials, the First Responders, it's residents, it's students, it's families, it's business leaders, it's workers, it's entrepreneurs, it's healthcare providers, it's prison population, and guards, it's Faith Community and all the challenges; all the opportunities and issues they face. Be it resolved that

residents and participation in this community are encouraged. I therefore have set my name and signature to this proclamation. Thank you very much.

REVEREND LINTERN: Thank you very much. If you would allow Me a few words, you have forced this preacher to sit quietly for two and half hours. That is unheard of. I went into ministry so I wouldn't have to sit still during church. (chuckles) But, I do want to say what your prayer was what my heart was thinking too. And I have, I was thinking the last twenty-five years the connections to Ocie Hill, have been pretty significant helping with the Minority Health Fair, Boy's Basketball, all sorts of things that have gone on and really have continued to this day. I want to remind you and as a historian, that building has already come down once. It was Bowman Street School; it was demolished in order to place that building there, and we generationally will take buildings down in order to rebuild them and I would... I'm not going to make solutions for you, but I do hope that there is the next generation as people have described. As a prophetic word though, God goes ahead of us. And often times when we come up with ideas, it's finally God has gotten our attention and whispered what is the solution. So, as we will be keeping you in prayer, certainly,

These next sixty-five days as they come out, and please notice the list, there are churches in each of your Wards that are part of this and I invite your participation, but even if you are not there, know that you are being prayed for and know that Ocie Hill will be a major portion of what we are praying for. Our First responders are almost every night, that is part of it. The addiction situations are there as well as everything related to the communities. And this has been a remarkable experience, last year was very surprising and I gave each of you a book. It's an easy read. And it's one chapter at a time, doesn't take very long, so just enjoy that. Pick out churches , especially in your Wards and notice it. But, we have even expanded this year. And it is not , it was not the intention, it's God's way of saying "something good is happening". So, please recognize that and thank you very much for this proclamation and for your, for your dedication and leadership in all this as well.

This is no guarantee we can't make the administration...uh, oh well here we go. Here just recently...

PHIL SCOTT: And here you go...

JON VANHARLINGEN: Yeah, here we go. Here just recently, a fine example maybe it was known, maybe it wasn't known...a PO was opened up to a mailing service in the amount of \$49,300.00; just underneath the threshold, well it wasn't but close to thirteen days later, the same company we turned around and opened a PO for \$12,000.00, because there was more that was needed. So, there you go, we're up \$60,000.00 right now and it never came through Council. It's all under Contractual Services. Not that anybody did anything wrong; I'd like to know where the money's going. So, that's the whole point of the Bill. There's some things this will not, this, the Administration has the right to do, but then again the key word that I'm looking at is projects. If there's more than two PO's, if it exceeds more than \$50,000.00, and you don't have multiple vendors, then it, I feel it's only right to bring it to Council.
