Amending Section 941.08 (Water Charges) of the Mansfield Codified Ordinance of 1997, as amended, to modify the rate structure and to increase water rates, and declaring an emergency.

**BE IT ORDAINED BY THE COUNCIL OF THE  
CITY OF MANSFIELD, STATE OF OHIO:**

**SECTION 1.** That Section 941.08 of Chapter 941 (Water Charges) of the Mansfield Codified Ordinance of 1997, as amended, be, and the same is hereby amended to provide as follows:

**941.08 WATER CHARGES**

(a) Water Rates Within the City. Notwithstanding any other provisions of these regulations, the following water rates shall be placed in effect, as forth below:

Each year after 2026, on the first of the year, the total rates shall increase by 3% from the previous year, rounded to the nearest cent if usage charges are in CCF units and rounded to the nearest ten thousandth of a cent if usage charges are in Gallon units.

The water rates shall be reviewed at least biennially and shall be revised periodically, as required, to reflect actual water works costs. The Public Works Director, or a delegate, shall be responsible for reviewing, retaining of documentation and making recommendations to Council for revising the rates set forth in this chapter.

The tap charges as listed include the removal and replacement of pavement, the removal and replacement of sidewalk, the cost of the shut-off valve, and the installation of a fire service line from the watermain to the shut-off valve. When feasible, the shut-off valve will be installed within the public right of way near the property line, otherwise the shut-off valve will be installed in the most appropriate location. In all respects, the shut-off valve shall be accessible to City employees.

**(e)(f)** The standard charge for turning on or shutting off of a water service shall be twenty-five dollars (\$25.00) for either action.

**(f)(g)** Customers will be supplied with one meter for each tap charge pursuant to subsection **(e)(d)**. Customers who need additional meters on a single tap for sewer deduct purposes, will be charged one-hundred ten **fifty** dollars (~~(\$110.00)~~ **(\$150.00)**) per additional meter.

**(g)(h)** A flat rate of one hundred fifty dollars (\$150.00) shall be charged for the water used during structure construction through the issuance of a building permit. This charge shall be payable at the time a tapping permit is issued. Depending on the scope of structure construction, the Public Works Director may require a meter to be installed and the use of construction water shall be charged pursuant to the water rates listed in subsection (a). If a meter is required, the flat rate listed in this section shall be waived. It is the responsibility of the consumer to provide and install an approved meter and to protect the meter from freezing.

**(h)(i)** For persons desiring cisterns, swimming pools, storage tanks or tank trucks filled from a fire hydrant or other unmetered connection, a charge shall be levied of five dollars (\$5.00) per one thousand gallons, but in no case less than the minimum of twenty-five dollars (\$25.00). Should it be necessary to disconnect and reconnect meter service for filling a pool, there will be an additional charge of forty dollars (\$40.00).

(j) All consumers located outside of the City's corporation limits shall have applied a one hundred percent (100%) surcharge to any and all rates listed in subsection (a).

(k) Notwithstanding subsection (j) hereof, the Public Works Director may enter into contracts, or renew or extend existing contracts, establishing rates other than set forth in subsection (a), as may be specifically authorized by Council.

(l) All work performed by the Division of Water at the request of a customer or any other person shall be charged at the Division's actual cost unless specific charges are listed elsewhere in this chapter.

(m) When a meter is removed for repairs and/or the meter is not functioning as intended and/or miscalculating usage, the service shall be calculated and charged at the average daily usage which occurred for up to the previous twelve months.

(n) A ~~minimum service~~ meter service charge in accordance with subsection (b) and a readiness to serve charge in accordance with subsection (b) (c) hereof will continue to be billed to the water service account even after termination of water service until the meter is removed.

SECTION 2. That the provisions of this Ordinance shall take force and be in effect for water bills in accordance with dates specified in Section 1.

SECTION 3. That existing Section 941.08 of Chapter (Water User Charges) of the Mansfield Codified Ordinance of 1997, as amended, be, and the same is hereby repealed.

SECTION 4. To effectively and properly administer water user charges, this measure is determined to be an emergency Ordinance for the immediate preservation of the public peace, health, safety and welfare of the City of Mansfield and its inhabitants and providing it receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its adoption, otherwise from and after the earliest time allowed by law, after its passage and approval by the Mayor.

Strongly supporting Ohio's application to receive funding from the Corridor Identification Program, and declaring an emergency.

WHEREAS, receiving funding from the Corridor Identification Program, which could eventually lead to Amtrak providing new passenger rail throughout the state of Ohio and specifically, near Mansfield; and

WHEREAS, according to Amtrak, one possible route connecting Cincinnati to Dayton to Columbus to Cleveland will generate \$130 million in annual economic activity and \$2.6 billion in economic opportunity from one-time investments; and

WHEREAS, the federal government is offering Ohio full funding to conduct a study to see if passenger rail is feasible, but the state government must apply for this money before March 20th, 2023.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MANSFIELD, STATE OF OHIO:

SECTION 1. This Council does hereby declare its strong support to any effort by Governor DeWine, ODOT Director Marchbanks and ORDC Executive Director Dietrich to officially apply before March 20th to the "Corridor Identification Program" for federal funding to study the feasibility of Amtrak expansion in Ohio.

SECTION 2. That the Clerk of Council is hereby authorized and directed to forward a certified copy of this Resolution, along with the attached letter (Exhibit "A") to Governor DeWine, ODOT Director Marchbanks and ORDC Executive Director Dietrich.

SECTION 3. This Resolution is declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the City; therefore, this Resolution shall be in full force and effect immediately upon its adoption by Council and approval by the Mayor.

Governor DeWine, ODOT Director Marchbanks and ORDC Executive Director Dietrich,

We write as elected officials and community leaders across the state to ask your administration to officially apply before March 20th to the "Corridor Identification Program" for federal funding to study the feasibility of Amtrak expansion in Ohio. Requesting this funding doesn't commit the state to building new passenger rail, but will ensure Ohio's planners have all the information needed to make an informed decision, without a cost to Ohio taxpayers.

The possible economic, travel and societal benefits of passenger rail to our communities are already well-documented.

According to Amtrak, one possible route connecting Cincinnati to Dayton to Columbus to Cleveland (3C+ D) will generate \$130 million in annual economic activity and \$2.6 billion in economic opportunity from one-time investments.<sup>1</sup> Another study<sup>2</sup> on a possible route from Chicago to Pittsburgh found that over 1 million new jobs and more than 3 million additional people are expected to live along this corridor by the year 2040. Ohio is landing new businesses across the state and we need to connect workers to be closer to these places of employment.

Just as important, increased passenger rail can expand opportunities for our citizens. Central Ohio remains the largest metro area in the country without passenger rail, and the last time Dayton or Columbus saw a passenger train was during the Carter Administration. Imagine the economic and educational opportunities when rural and big-city Ohio is finally connected and underserved communities, students, the elderly and others are able to freely move between our cities and towns at lower cost than maintaining an automobile.

However, none of these possibilities can become reality if your administration doesn't apply before March 8th to the "Corridor Identification Program". Applying for this program will give Ohio time and federal resources to work with Amtrak to identify the corridors where passenger rail can be placed, assess the cost and look at infrastructure needs. It will not commit the administration to building any projects.

We ask the administration to take an important first step and apply for this funding by March 20th.
