Authorizing the Public Works Director, to sign documents which must be executed in order to participate in the relevant Teva, Allergan, CVS, Walmart, and Walgreens Opioid Settlements, and declaring an emergency.

**WHEREAS**, the State of Ohio, through its Attorney General, and certain Local Governments, through their elected representatives and counsel, are separately engaged in litigation seeking to hold Opioid Pharmaceutical Supply Chain Participants accountable for the damage caused by their misfeasance, nonfeasance and malfeasance, and

**WHEREAS**, this Council has already authorized signatures for the material terms of the proposed National Opioid Settlement Agreement, and

**WHEREAS**, that in order to meet the timelines established to confirm participation in additional settlements, the Public Works Director, on behalf of the City, must execute additional documents by April 18, 2023.




**SECTION 1.** That the Public Works Director, on behalf of the City, is hereby authorized to execute the documents necessary in order to participate in the relevant Teva, Allergan, CVS, Walmart, and Walgreens Opioid Settlements.


**SECTION 2.** That it is found and determined that all formal actions of the Council relating to the adoption of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements.

**SECTION 3.** That by reason of the immediate necessity to enter this agreement for is to ensure prompt pursuit of funds to assist in abating the opioid epidemic throughout Ohio, this measure is determined to be an emergency ordinance for the immediate preservation of the public peace, health, safety and welfare of the City of Mansfield and its inhabitants and providing it receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its adoption, otherwise from and after the earliest time allowed by law, after its passage and approval by the Mayor.

Authorizing the Mayor, Safety-Service Director, Public Works Director and Human Resources Director to enter into a Collective Bargaining Agreement with the International Association of Firefighters (IAFF), Local #266, and declaring an emergency.

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MANSFIELD, STATE OF OHIO:**

SECTION 1. That the Mayor, Safety-Service Director, Public Works Director and Human Resources Director be, and they are hereby, authorized on behalf of the City of Mansfield, Ohio, to enter into a three-year Collective Bargaining Agreement with the International Association of Firefighters (IAFF), Local #266, a copy of which Agreement is currently available from the Human Resources Department.

SECTION 2. That by reason of the immediate necessity for entering into said Agreement pursuant to the negotiations, and to promote harmony with City employees, this measure is determined to be an emergency Ordinance for the immediate preservation of the public peace, health, safety and welfare of the City of Mansfield and its inhabitants and providing it receives the affirmative vote of two-thirds of all members elected to Council, it shall take effect and be in force immediately upon its adoption, otherwise from and after the earliest time allowed by law, after its passage and approval by the Mayor.
