REGULAR COUNCIL MEETING February 15, 2022

The second monthly meeting of Mansfield City Council met on Tuesday, February 15, 2022 at 8:36 PM in the Council Chambers of the City Building.

The Pledge of Allegiance was recited by the audience.

Eleazer Akuchie led the audience in prayer.

ROLL CALL: The following answered present at roll call: Burns, Meier, Akuchie, Davenport, Diaz, Moton, Scott, Zader and Falquette.

There being no objections, the reading of the Journal and Correspondence was dispensed with.

PUBLIC COMMENTS:

PRESIDENT FALQUETTE: Anyone wishing to speak before council. We have two people, sorta three. Deborah Mount is first. Name, three minutes.

DEBORAH MOUNT: Deborah Mount, 114 Cliffbrook Drive. Two things. First thanks for the answer on whether citizens can hire a private plow. When I searched the ordinances there was nothing. So, I would hope that City would make that more clear, if that is the city's policy. However, there's a liability obviously if a private company was to plow the roads. But our Street 4 days into the storm, was still not plowed. 12 inches of snow. My sister works in the hospital. Is there not some liability on the city's part for plowing in a suitable amount of time. I know there was a lot of reasons that didn't happen. We plowed...we shoveled the street by hand in front of our house. Took quite a long time. But what else is there to do? The city did not come 4 days in, it was still that deep. 4-wheel drive trucks were stuck. Please take that into consideration. you probably need to be more clear on your policy. But on the other hand, 4 days in and people, essential workers, not able to get to their jobs is a problem. And then secondly as you consider the fireworks issue. If you decide to let them be legal, I would wonder if you could please consider banning some of the bigger kind. Specifically, last season we had m80's set off between 2 and 4 in the morning. It sounded like a house exploding. And especially in those hours, that did not sit well with the neighborhood. So please take that into consideration. At least hours that it occurs and size. Because when it sounds like a house or cars exploding, even if it is legal, you're going to be getting calls because that sounds pretty bad. So, I'm hoping you'll take that into consideration. Thank you

PRESIDENT FALQUETTE: Thank you Ms. Mount. Jill VanHarlingen and Teri Marlow are coming up as a joint commentary. So please state your names, address and three minutes.

JILL VANHARLINGEN: My name is Jill VanHarlingen and I live at 918 Linden Circle West. And I had no plans of speaking tonight, but I wanted to just...point that was made about the police review commission, about the background check. When Jon was on Council and he tried to find some, he worked really hard to get somebody on this, I can tell you. And he had one lady that was a great candidate. And course you have to go through the background check. She would call in weekly, "Have you heard anything? Have you heard anything?." It was weeks, maybe even months before that background check happened. And she finally called and she said "I have other things to do, I'm doing other things, never mind." So, we lost that candidate. Fortunately, Teri Marlow here. He found Teri, third ward, you're really lucky Rev. El. she's dedicated to the police review commission. And I know she wants to stay on it, but something has to do about the background check. I don't know what the snag was, cuz I don't understand

that process. But... (someone is speaking but can't be understood due to mic being off). That what it was? Well something's not working, I'm telling you that's going to be a snag for you. So, I'll let Terry talk about her experience on the police review commission.

TERI MARLOW: I live at 616 Cline Ave. I've been on Review Committee, I think for about 4 years now. And during that time, we've had Covid and that's a big reason why we have not been able to meet. We went to every other month. Which was a lot of confusion for some of the people. And most of the decisions are already made before we come in and meet. We do get to hear what happened. We read it over. We discuss and if everything's pretty much okay then we go ahead & sign it and then whoever made the complaint will receive a letter stating that we went over it. The police department they did a wonderful job in training us. And yes, it was for hours. They did treat us to pizza and drinks too, that was nice. I mean it's really a blessing to have this. And I think it would be very detrimental to our community if you decided to disband. Everybody that I'm on this commission with, I've not heard anybody who wanted to leave. We do have two empty spots on it. So, if we could get those filled and get the rest of us back in there. We actually are planning to meet Thursday here at 6:00pm. If anybody wants to come, they are more than welcome. We've only had one city council person to our meetings since I've been there in 4 years.

PRESIDENT FALQUETTE: Thank you Miss Marlow.

JILL VANHARLINGEN: How many meetings did you miss?

TERI MARLOW: One.

AMY YOCKEY: Councils not supposed to be involved in it though. Because its...I'm going to leave that up to you.

PRESIDENT FALQUETTE: Maybe we can have the Law Director make a response at a later time. We don't have to have all the details. Unless you have them quickly available.

CHRIS BROWN: I can follow up more thoroughly later. But I think the idea is it's meant to be confidential. To kind of allow the Police Department to you know delve into the internal affairs. And then I will say if you look at the code you, city council, and the mayor can both request reports from the commission. So, I think that that might be a little bit more proper way to handle figuring out what's going on and keep tabs on it. But like I said we can follow up more thoroughly later if you like.
