

**REGULAR COUNCIL MEETING**  
**March 1, 2022**

The first monthly meeting of Mansfield City Council met on  
Tuesday, March 1, 2022 at 8:15 PM in the  
Council Chambers of the City Building.

The Pledge of Allegiance was recited by the audience.

Eleazer Akuchie led the audience in prayer.

**ROLL CALL:** The following answered present at roll call: Burns, Meier, Akuchie, Davenport, Diaz, Moton, Zader, Scott and Falquette.

There being no objections, the reading of the Journal and Correspondence was dispensed with.

**PUBLIC COMMENTS:**

**PRESIDENT FALQUETTE:** Anyone wishes to speak, we'll have public comment. Mr. McNeil is up first. Mr. McNeil are you done?

**ESTHER MCNEIL:** It will be quick. I jotted down a couple things here. One the water line that's broken on Adams Street been running for at least 3 weeks. Whose responsible for that? I call the street department. I guess they came up there and looked at it. Cause there's a cone there. But I talked to the homeowner directly in front of that and he said the city gave him 3 days to get it fixed. Now I don't know whose responsible for that but it's a shut off valve that's busted. Whose responsible for that? The homeowner or the City? It's like someone run into a fire hydrant, but it's just a shut off valve. It's been running for a couple weeks, 3 weeks. So, I'm gonna tell him he's not responsible. I don't think. Uhh, Mansfield. What part of Ohio is Mansfield, like when you go to get money from, what part of Ohio is Mansfield set up with? Anybody know?

**PRESIDENT FALQUETTE:** Just to remind you Mr. McNeil that your allowed to make comments. Were not here to answer any questions at this time. Maybe somebody will get back with you or something.

**ESTHER MCNEIL:** Well I'll tell you it's the East side of Ohio. Youngstown and them places, Akron. It's the East side. I went to a meeting at the University of Akron 3 years ago and that's how I found out. There's grant money that was supposed to be given out to the cities. When Mansfield's name came up they didn't want it. Youngstown said "if Mansfield don't want the money, we'll take it." And they did. So were in line with the East side of Ohio. So, somebody needs to check that out. Were not in line with Columbus, were not in line with Cleveland. It's the East side of Ohio.

**PRESIDENT FALQUETTE:** About 30 seconds sir.

**ESTHER MCNEIL:** I can stand for 30 seconds, right? Alright, good. You got it.

**PRESIDENT FALQUETTE:** Thank you Mr. McNeil. Carl Hunnel?

**CARL HUNNEL:** Good evening. Let me preface by saying I had no intentions of speaking tonight. And let me also throw in another preface, what I'm about to say has nothing to do for or against the legislation your going to vote on tonight. Apparently 22-032 and 22-033, I have no idea what's in it. The memorandum

of understanding. I have no idea what the contract is. But I want to speak on behalf of the public. I write stories for Richland Source. On Friday, I get legislation. I write preview stories. I let people know what Councils doing. Clearly stated caucus only. I didn't worry about asking for details because it said caucus only. Weren't going to vote until March 15th. I come tonight, executive session, you come out. You guys often talk about the need for multiple readings. I've seen you have multiple readings to spend twenty-five thousand dollars to buy a truck. And tonight, with no readings your going to vote on legislation that's going to spend a whole lot of the public's money. And they have no idea what it is your voting on. They've not heard about it. They don't know if its justified or not. They don't know why. And when you vote tonight, no ones going to want to say anything. No copies are going to be made available. Eventually it'll trickle out what your doing. 2019, the last time you approved this contract, nothing was put out about it. This contract doesn't end until the end of July. According to what I saw tonight, this takes effect today March 1<sup>st</sup> according to notes the Finance Director put out. I'm not saying it's wrong or right. What I'm saying is you often talk about letting the public have input before you make decisions. Tonight, your going to vote, and you not only not going to allow the public to have any voice in it, you're going to vote on something that you said in your legislation you weren't going to vote on it till March 15<sup>th</sup> and now your going to vote on it. Thank you very much

**PRESIDENT FALQUETTE:** Mr. Mayor? Hold on, do the microphone thing

**MAYOR THEAKER:** Tonight, I have a proclamation. Troy Smith is here along with Sam Myers. Sam Myers is an Olympic swimmer for the disabilities. I really admire you for being on the swim team. What do you swim?

**SAM MYERS:** (inaudible talking)

**MAYOR THEAKER:** Good job, congratulations.

**TROY SMITH:** Were heading to Bowling Green this weekend for state. So were going to head up Friday night, stay in the hotel with the team, grab dinner and swim at Bowling Green on Saturday.

**MAYOR THEAKER:** I think that's great. Good job (clapping). So, this is March and we usually do this always, or we try to. I think last year we didn't do this because...

**TROY SMITH:** Last year we were off.

**MAYOR THEAKER:** ...of the pandemic. Development Disability Awareness month is March. So I have a proclamation I would like to give to Troy. Whereas, more than 1,500 individuals served by Richland Newhope, their families, friends, neighbors, and co-workers encourage everyone to value and respect the abilities of all people; and whereas, the most effective way to increase this awareness is through participation in community activities and the openness to learn and acknowledge each individual's contribution; and Whereas, policies must be developed, attitudes shaped, and opportunities offered that allow citizens with developmental disabilities to live as independently and productively as possible in our community; and Whereas, we encourage all citizens to foster and support such opportunities that include full access to education, housing, employment, and recreational activities. Therefore, I, Tim Theaker, Mayor of the city of Mansfield, do hereby proclaim March 2022 as Developmental Disabilities Awareness Month. Congratulations and if you want to say a few words...if you want to go ahead and say something.

**TROY SMITH:** Give Mayor Theaker your spring photo.

**SAM MYERS:** Yep.

**TROY SMITH:** Here ya go Mayor Theaker

**MAYOR THEAKER:** Great. We'll hang that up in here.

**TROY SMITH:** Please do.

**TROY SMITH:** Pizza man from Donato's.

**SAM MYERS:** Yep. On Tuesday. And I have a girlfriend. (cheering from audience) Thank you so much.

**TROY SMITH:** Thank you Sam. So you guys, on Tuesdays he works at Donato's. What hours are you there?

**SAM MYERS:** I am 10-2.

**TROY SMITH:** 10-2

**SAM MYERS:** Yep

**TROY SMITH:** We just want to thank you for your support through Richland County, it means the world to us. Some of you will be able to attend our bowling event tomorrow, its for 7<sup>th</sup> and 8<sup>th</sup> grade students, with or without disabilities as well as dignitaries such as yourself. We'll collaborate as teams. Gionino's is catering lunch. Culligan donated water. We have a great support. Some of the media we hope will make it out there, make their way out. Hopefully some more of you can join us next year. Thank you all very much.

Currently our Public Works Director and Interim Safety Service Director Ramey is handling all manners of risk management. This will house that into a separate position. Which I think is a very substantial work load just in and of itself that could absolutely occupy a significant portion of the individuals time. When we say risk management, what we generally mean are issues related to our general liability insurance. Oh, for example, there's an accident. Ok we need to make sure that gets reported properly, things of that nature. Anything dealing with our general liability insurance. As well as procurement. That's purchasing, bidding, all things of that nature.

**CHERYL MEIER:** And who will that person report to?

**SHARON MAY:** They will report to myself as the HR Director.

**PRESIDENT FALQUETTE:** Thank you Mrs. Meier. Does anyone else have any further questions? Hearing none, Ms. Moton.

**KIMBERLY MOTON:** Thank you Mr. President I move that bill 22-033 be placed upon the floor for final consideration.

**CHERYL MEIER:** Second


**PRESIDENT FALQUETTE:** Hey it's moved to close, seconded. All those in favor say aye.


**COUNCIL MEMBERS:** Aye
