# REGULAR COUNCIL MEETING March 15, 2022

The second monthly meeting of Mansfield City Council met on Tuesday, March 15, 2022 at 7:18 PM in the Council Chambers of the City Building.

The Pledge of Allegiance was recited by the audience.

Eleazer Akuchie led the audience in prayer.

ROLL CALL: The following answered present at roll call: Burns, Meier, Akuchie, Davenport, Diaz, Moton, Zader, Scott and Falquette.

There being no objections, the reading of the Journal and Correspondence was dispensed with.

PRESIDENT FALQUETTE: We did have a correspondence. I'm hoping that James is ready. A number of people participated in a bowling with the mental health group. We had a resolution; proclamation and this short video is from that. And I thought we could show it real quick. If you can go ahead. It may be a little stuttery but we're going to see if it plays. And if it plays great. If it doesn't play we'll move on. But it it's really short. So, I thought it would be appropriate just to show the New Hope bowling event. (plays video but no sound in chambers came through the speakers). You can hear it in the office. They can probably hear it online, we can't hear it here. So, we'll work on this video capability. (video sound plays the last bit of the audio through chamber.) And there we go, that was it. Hope that was acceptable. Let's see. Speaking before council tonight. We have Deborah Mount. State your name and three minutes top. And let's roll. Thank you.

### **PUBLIC COMMENTS:**

**DEBORAH MOUNT:** Deborah Mount, 114 Cliffbrook Drive. Coming to follow up on a few emails that I'd sent in the last week or two. One, it wasn't said publicly but I've heard, bill 37 has been pulled at least temporarily. But I am requesting that before that proceeds, that several answers be provided. Namely I did get a forward from Clerk Yockey after this meeting had started about some minutes from the 2019 and 2020 meetings for the police review commission. However, I have been told that the commission, though their terms have been expired for about a year, has met in the time when there was nobody on the commission legally. So, I would like council to investigate and find out what was done at those meetings. what official business was taken when there was no one on the commission. Also, regarding the names that have been put forward. I'm wondering if the ward council people put those forward. And if not, how did that come about those names were brought forward. I'm hoping that again you can find out the goingson of that commission, cuz it seems like it's some things have been happening that Council was not aware of. And I'm hoping that you'll do your due diligence before bringing that forward again. And then secondly before the final budget is approved I had asked last week, the public is not really allowed any say in the process, but I had asked after the committee meeting and then emailed my questions that answers be found regarding two topics. The Mansfield Police Department having been budgeted for 87 officers but has been short of that number by 12 to 18 officers much of the time. I would like to know where, I'm hoping you would investigate and find out, where that money goes that was budgeted and for what is it ended up used. Cuz it's not for safety, once it is not used by them. Also, Assistant Fire Chief had mentioned the general fund transfers to safety used to be transferred 1/12th of the allotment per month throughout the year. That has changed and it's only now, even though the money is budgeted, the amount of transfers only the amount of deficit theoretically. So, I would again like to know that's our tax dollars,

what is happening to those dollars when they are not being used for safety and why did that change. Thank you.

PRESIDENT FALQUETTE: Thank you Ms. Mount. Lance Cook.

LANCE COOK: Hello. Thank you for having me again. My names Lance Cook. I'm the president of ASCME Local 3088, which is the city workers union. First, I'd like to start off by saying I thank everybody for all your work you've done to help us with telecommunications. Their doing real good. They've hired new people, and they got a lateral transfer. So, all the work we did about a month or so ago is starting to pan out wonderfully. Also, I'd like to take a second to recognize the income tax personnel. This is a rough time of the month for them because they collect taxes for you guys. Them and the Utility Collections I always say they are the most important departments because they keep the lights on here. Because utilities pay our water and sewer and fund everything. And income tax collects the money we need to function every day. Also, I'd like to let you guys know that we have...there's been rumors and conjectures as far as our Me-Too clause. We are going to exercise that were going to enter into discussions with the city Monday morning over that. Were going to continue to work with the city on one of the issues covering that. And that's about all I have to say about that right now. Just letting you know. Ok? Thank you very much. Appreciate it.

**PRESIDENT FALQUETTE:** Thank you Mr. Cook. Art Bailey. Mr. Bailey we've got a three-minute limit here. This is your opportunity to address council but we really don't interact or answer questions or anything like that during this period. Go ahead. State your name and address. And push the button one more time. There's a button down at the...in the...you got it.

ART BAILEY: Right here? I got it. My names Art Bailey. I live on 72 Arnold Drive. And the Rev. El asked me to. I've been communication with him because he physically was on property and seen what was going on at our property on 72 Arnold Drive. So, I bring it before council that however I can get some help. I represent three families that live on that drive. About two weeks ago the City Water Department came out and cut another section out of our driveway where we had a massive water leak. They repaired it with concrete. But if you go back up into our area right now, Rev El witnessed it, there was so much property damage done with their trucks and the grasses. They busted up our blacktop going up into the drive with their big trucks and the suction machine was up there. So were just looking for somebody to, I mean I have numerous pictures of the damage, but somebody that can help us that can get that place back to square one. I usually call him Judge Spon, he talks about this Council helping citizens. Well we need help. They came out there and did this. So, they should be responsible for repairing what they did. I don't know who to get in contact with other than I talked to Rev. El. He personally came out and said "hey bring this before the council members. Let them hear what's going on and see what can be done." Because it's a terrible sight up there right now. And like I said, were only the three houses that's on that drive. And our property and everything is horrible right now. So, I'm just asking you for somebody that can help me out, help the people out there. And I just thank you for your time. And I appreciate that.

**PRESIDENT FALQUETTE:** Thank you for bringing that to our attention. Alright, appreciate it. Easther McNeil.

**ESTHER MCNEIL:** Good evening. I jotted some things down, so I'm not going to take too long. Don't worry about three minutes. The gentleman up there where they had the water leak he wants to thank the city for doing...for stopping that leak. I thank you too, and he thanks you. Another person came to me about the apartments up there at Eastgate, Holdens LLC. Roaches, rats, bugs, whatever. And he's tried to get in touch with the owner but the owner lives in New York. The manager won't give him the telephone number. So, I guess who should he go see? Codes and Permits or what? Anybody know?

**PRESIDENT FALQUETTE:** Remember Mr. McNeil you can ask, we're not interacting on this. Sorry but maybe after the meeting we can help you out a little better or something.

**ESTHER MCNEIL:** Alright. Next right across from my house they had a water leak there 2 years ago. I don't know if it's contractors or city. They dug up the grass there. In two years, it hasn't grown. But they put cement, rocks where they took off. That's on Arch Street. And one other thing I probably should ask the Union President. Union President?

PRESIDENT FALQUETTE: Mr. McNeil your only allowed to...

**ESTHER MCNEIL:** Alright, alright. I'm taking up time. If I was sitting up there, the high school stadium. I would have long-time put a head help...put a dome on that. Because you want to grow the city. A dome on that would probably get that area people coming in building. It is one of the best high school stadiums in the state or country. But you can only use it what 2 months out of the year.

I am of the mind that we continue that process because I am hopeful that at some point in time we get to that number. If we were to budget for, say where we are. And then they do a hiring event and were to receive candidates, enough candidates to fill the spots. We would then run into the issue of not having budget enough to fill those spots. I am of the mindset that a big reason. A big part of policing, is community policing. The fact that our officers currently are under staffed and have to move from call to call does not allow them the opportunity to get into the community and learn their community. To learn the people who are in their community. And for our community to learn who they are. So, I will always be in the in favor of keeping that budgeted at 87. Regardless if we're there or not I am hopeful that at some point in time we get there to the 87 number. I do believe getting to that number will go a long way to creating the relationship between

Regardless if we're there or not I am hopeful that at some point in time we get there to the 87 number. I do believe getting to that number will go a long way to creating the relationship between

community and police that I so desire and the rest of the community desires. So, as it is right now that money does get moved other places. Mainly to the fire department at this point in time. When that money is not used. But that's where that is. The policeman grant compels us to and like I said I will always be in favor of keeping it budgeted at 87 every year until we hit that number. And I do want to kind of give my final thoughts on the budget. You know there's been a few more days of me looking into it, more conversations I've had. And I'm going to say I'm very nervous about our current budget. And it's no fault of the administrations, it's no fault of budgets. It's simply where we are going in terms of gas prices. In terms of inflation. In terms of...those things cannot be budgeted in October. I've spoke about my fear for the codes and permit with their inability to hire an architect. And they having to do that work. The IT Department, I am fearful for. Because as Director Weiner spoke about earlier, he has no capital. And all his whole department is run on capitol. Maintenance, because you cannot see the things that come at maintenance. Of course, safety will always be a concern, they can never have enough money. So, there's a lot of concern that comes with this particular budget. The one thing that gives me solace and cautious optimism, is the fact that our current budget is not a true depiction or true reflection of what our financial situation will be in 2022. Because it does not take into account the 10 million that we will receive from ARPA in June or July or whenever it's supposed to come. The reason I say its cautious optimism is because we don't currently know what the guidelines are going to be for that money. The hope is that it will be similar to last year. That we will be able to put away a good amount for revenue replacement. Which allows a lot of flexibility. The hope is that some of that money will be able to be placed into those departments where we have concern. So, to where they can continue to run throughout the year and not come to us for \$9,600 the way the IT department had to come to us today. But like I said, the reason for this caution is the feds could come down and say all that money has to go to infrastructure. Now Mr. Bianchi would love that. But it would not allow us to do some of the other things that we are going to need to do with that money. So, as I say there is cautious optimism for our financial prospective for 2022. And I do want to give kudos to the Finance Director and Administration for putting together this very tight budget. And doing what they could best. Like you know they prioritize some of the things that we do think need to be prioritized. But we can always use more money. And we simply don't have it. So, it is very tight, it is an extremely tight budget. But like I said it is not a true reflection of what our financial outlook will be for this year and with that I will yield.

**PRESIDENT FALQUETTE:** Thank you. Is there any other questions or comments on bill 22-031? Mr. Davenport would you like to move it forward for a final vote this evening?
