REGULAR COUNCIL MEETING March 16, 2021

The first monthly meeting of Mansfield City Council met on Tuesday, March 16, 2021 at 7:52 PM in the Council Chambers of the City Building.

The Pledge of Allegiance was recited by the audience.

Councilman Lawrence led the audience in prayer.

ROLL CALL: The following answered present at roll call: Burns, Meier, Van Harlingen, Davenport, Lawrence, Moton, *Scott (motion to excuse passed)*, Zader, and Falquette.

There being no objections, the reading of the Journal and Correspondence was dispensed with.

SUSPEND RULES

LAURA BURNS: Thank you I move with respect to all bills that come before council this evening that the rule requiring reading on three different days be suspended and that each bill be read one time by title only, seconded by Mrs. Zader. The vote was taken and resulted as follows: Ayes: 7, Nays: 0

PRESIDENT FALQUETTE: Ok we have a motion and a second.

ADMINISTRATION COMMENTS

PRESIDENT FALQUETTE: Mr. Mayor you have anything this evening?

MAYOR THEAKER: Yes Mr. President I do.

PRESIDENT FALQUETTE: All right.

MAYOR THEAKER: At the federal level the office of management and budget has the idea that they want to change the classifications of different cities. Mansfield being one of them, along with two other cities in the state of Ohio. Where are we would not be called a metropolitan the area anymore. That causes some issues for funding. If we are not classified as a metropolitan area, we could and will probably lose our CDBG money, home money and regional planning may disappear or their funding may be cut. Along with the possibility of the transit authority being cut and funding. And there's other repercussions that we would get because of the money that we're getting from this Relief Fund was based upon our classification being a metropolitan area. Cut a long story short what I am emphasizing to everybody is please and I will send the link out tomorrow, but we need to get a letter writing to the Office of Management and budget to oppose this reclassification from a metropolitan area to a non-metropolitan area because that will be extremely detrimental to the funding in the City of Mansfield and the county. So, I will send it out to media and also send that out tomorrow to all of council to try to get a letter writing out there so that we can emphasize that this is something that will be detrimental. We've been working very hard to build ourselves back up from where we were a few years back and this would be detrimental.

PRESIDENT FALQUETTE: Thank you Mr. Mayor that's extremely important and appreciate you sending this link to make it one step easier and I hope everyone can get onboard help us out with this campaign. Anything else Mr. Mayor, I don't think you did, right?

MAYOR THEAKER: Nope that's only other thing is I ensure everybody knows that the City of Mansfield will get about 22 million dollars from this Relief Fund and we are in the process of trying to formulate where and how we would like to spend the money. But we also need to get a little more clarification and so we're going to be getting a clarification from the Ohio Municipal League Thursday along with Director Stewart and trying to make sure that to spend the money correctly and appropriately.

PRESIDENT FALQUETTE: Very good thank you Mr. Mayor. Director Cope, do you have anything this evening?

LORI COPE SSD: Mr. President if I may, I was having some technical difficulties during the finance meeting. So, I just have an invitation for Councilwoman Zader, if you would please. The Chiefs safety forces, Chiefs appeal the budget hearings are always very, very valuable for them and since we haven't done that if you would like to meet we would be happy. We basically want to share a little clarification that we when we do our temporary budget we use the numbers given from Finance, their predictions and prepare our temporary budget of needs. We have not had the luxury of a wish list for a number of years and so we do focus on their needs list. So, if you do get an opportunity, and please make time to meet, we would really be happy to go over those with you and that's all I had the Mr. President.

PRESIDENT FALQUETTE: Thank you Director Cope. Director Remy, do you have anything this evening?

DAVE RAMEY: I would have a short update on the meter project kinda keep everybody abreast of what's going on. We are approaching 13,000 meters installed. There are a little over 800 appointments scheduled. We are in the process of installing large meters, and large meters are anything that's 2 inches or larger. We have installed 230 of those and we have appointments to schedule to install large meters, that schedule runs through April. We are sending out a flyer or Suez is sending out a flyer with utility bills to those people who have not responded in any way to the notices that we put out publicly through the press releases. In fact, the mailer is the press release, the last press release that I put out. But it is going to individual households that have not responded in any manner to the to our request.

PRESIDENT FALQUETTE: Thank you Director Remy, appreciate that concise report. Director Spohn, do you have anything this evening? Director Spohn you're on mute or something...

JOHN SPOHN: No, I do not.

PRESIDENT FALQUETTE: Thank you Director Spohn.

PUBLIC COMMENTS:

PRESIDENT FALQUETTE: And if there's nothing else, I think guard next step is, and I'm running a little behind, is to...is there any other thing that come before Council before we start voting on legislation and I think we do have a public comment from Lee Tasseff from Destination Mansfield. I think we can start with him, hopefully Lee is in the 5-minute time frame.

LEE TASSEFF: I'll do my best.

PRESIDENT FALQUETTE: Thank you. He has some big news and I'll let him explain what's going on.

LEE TASSEFF: Good evening everybody nice to be back in front of you, at least online anyway. Absolutely thrilled to present our only project that made it, that actually survived 2020 and that is our all new visitor guide. And thanks for Amy for putting the cover of it up on your screen. For those of you who haven't checked your mail boxes, you have it in your mailbox in council office. If you've gotten your hands on it by all means hopefully you enjoyed it and went through it all. If not there's one waiting for you or if you want to see it online you can do that by going to DestinationMansfield.com and click through to order a free visitor guide but you can get to the online version of it then. This guide represents something very different for us and how we present the community. It's a magazine style, a big departure from the traditional smaller brochure style of the past. The idea was we needed to do something completely different move ourselves into a different stratosphere. So, we created a more lifestyle-oriented publication. Gives us a much bigger, better platform to positively position the area and we think we did that. We tweaked our story telling with a series of short articles in there. Bolder photography that dominates the guide. It entertains and educates rather quickly so people can be pulled right into it. We like to say because we're small entity that we build networks of talent. So, we had to build some new partnerships in order to create this guide. Which was...which was exciting and took some time, I guess you could call it the Covid pause in what we were doing. We pour all our time into this one. It's also ready for adapting for the new community brand, whatever that becomes whenever that's finished, hopefully later this fall. It should have been the very first marketing piece that incorporated the new brand but obviously that got paused in 2020. The new platform can be expanded to become a more overall community-oriented marketing piece. That's why we needed to go to something bigger. It makes a definite improvement. It's more of a leave behind or something for your coffee table as well, you'd use an old term, that was all part of our design. In any case we're happy to feature Kingwood on the cover, that's what you see there. We just told the kids, we took a number of photos that night, just told the kids hey mill around and they started chasing each other and they came right at the camera one time and you're looking at the final version of that, which we couldn't take our eyes off. But Kingwood was actually on the cover of our 2020 guide but how many remember that? Nobody. Nobody saw. Why? Because the vast majority of them got recycled. All the time and investment we had into those. There was a loss of money for that but they didn't get distributed. Those that were distributed nobody picked them up. In fact, we had a house cleaning so to speak with the office today where we threw out everything from last year and it was sad to see all those guides go. But Kingwoods ready, they're ready to be prime time this year in a much better position in the world last year and we're happy that they're on the cover. We give them a doover and also, they'll be...a lot of our ad campaigns featuring Kingwood because it's their time for them to do that. Just briefly before I tune out, I'm definitely more optimistic about our local travel economy it's still going to take a couple years for it to come back but for us internally we're happy to be back in the game rather than sitting and watching as we did a lot last year and trying to reorganize. One of the things we, we look at multiple indicators for how things are going, our calendar event online about six weeks ago stopped losing events and we actually started adding them to it. Full race season at Mid-Ohio major events are returning. DMI is bringing back Final Fridays. We've already got writer's, influencers scheduled to come toward the area and stay with us. Mayor reference Covid Relief Fund, there's some aimed at helping the tourism and hospitality industry, which is nice because it was one of the hardest hit when everybody stopped going out and going places. And one thing I wanted to bring up before I go, I probably have mentioned it before but a lot of major projects in the community got paused, they didn't get terminated or stopped, never to come back. Bring back to life, they just got paused. For instance, we just got our letter talking about engineering study for the Main Street Corridor project. Y'all can inspect their basement anytime. Were on 124 North Street. All of that stuff bodes well for the future of the community. Things like that, that made it through. You got a public art initiative; fully funded projects are being reviewed. I talked about Kingwood and you got the art center opening they've already had their ceramic glass blowing accretion link open. They will finish their outside pavilion. You've also got Ohio State Reformatory that launched an incredible virtual tour of the country tuning in the end of 388

elevators ramp to link new parking access to their main ground is being there set for future events in imagination its funding secured in this is now reading all that stuff as well weather at all this year or next couple of years if we spray industry in the community and overall economic help as we looked at it when there's other things to report but I wanted to take the time and thank you for the president for letting me do it and for Amy throwing the cover up there.

PRESIDENT FALQUETTE: Thank you very much Mr. Tasseff. I noticed there were 38 pages in that brochure and every one of them was packed with phenomenal information. That's a very interesting piece, very well done.

LEE TASSEFF: Thanks. It was intended to be a little larger piece but that was what could be supported through advertising because of last year. So we're hoping when they come back it's a platform we can use to be an overall community marketing piece, not just for tourism. We've been headed in that direction anyway and that's why we decided this project was important not. It will just go ahead and reinvent it.

PRESIDENT FALQUETTE: Okay thank you very much Mr. Tasseff. Again, appreciate the concise report and very, very well-done brochure. Thank you.

LEE TASSEFF: Have a good evening, catch you later.

PRESIDENT FALQUETTE: Um next up further communications, I think tonight we have a bill that's in process 21-045, it's probably the most exciting bill we've had on before city council for some time. We heard from all of the registered collectors last week, nobody was really in favor, everybody was so willing to do what we wanted to do. Ee also had a number of responses from citizens around the city and the last count I had zero or for it and Amy Yockey our clerk I think she has a count of the number of negative responses from the community.

JAMES WEINER: Mr. President I just received a text from Amy, she has lost power at home. Therefor has no wi-fi, so she won't be able to answer that at the moment. Give me a second, I'm working on getting logged in as the controller to be able to handle your voting.

PRESIDENT FALQUETTE: All right well I'll let you do that and I'll just rounded unless somebody, does any of the council members see that email from her?

STEPHANIE ZADER: I saw it. She sent us 47.

CHERLY MEIER: 47.

PRESIDENT FALQUETTE: 47...

CHERYL MEIER: I don't know if that includes any of the emails or calls that we got personally. It was a lot.

PRESIDENT FALQUETTE: And so, it was overwhelming. 0 to 47 + against this legislation. So talking about communication I just I don't want to gloss over I really appreciate every single citizen that took the time to write, call, email but just to hear the same story 47 + times, I don't think the benefit to the council.

JASON LAWRENCE: Mr. Falquette, it is my bill and I just wanted to keep you up-to-date that 21-045, I have talked extensively with the law director, what is the proper way to for lack of a better term kill this bill and I would like to hear from my colleagues their thoughts, feelings up or down. I think the best way

to do it is to move it forward tonight for vote and then vote it down. That's what I'm proposing or we can pull it that I think it's the other choice right

PRESIDENT FALQUETTE: Right.

CHERYL MEIER: What's the benefit to tabling it? Or is there a benefit?

PRESIDENT FALQUETTE: My personal thought on tabling is, it's like we're going to talk about it some more we think there's something to add to it, we think that maybe someday we'll take it off the table. I don't get a vote unless it's a tie, so it's really up to the council people. If anybody on council wants to keep pushing this forward as it is then we should keep talking about it we don't even have a map yet.

CHERYL MEIER: I don't want to talk about it as it is but I know that there are certainly other issues pertaining to this that could be brought up. Is it just easier to bring forth legislation, that new legislation that's pertinent to what we're talking about?

PRESIDENT FALQUETTE: I think so. I think its so much cleaner. Let's start with a brand-new idea if we need one and just get rid of this one. The sooner I think we get rid of it the sooner every body can sleep again at night and not worry that their trash guy is coming on a different day.

STEPHANIE ZADER: Can I move that we put it to a vote?

PRESIDENT FALQUETTE: I would like to do it in sequence, so I think this is a precursor. I think it's like the third bill. So, when we hit the third bill Councilman Lawrence can read it and make a motion to do what we want to do. Then we can vote on it the way we want to vote on it. But I think this is a good little pre-discussion to where were headed. So, with all that said about refuse I was not made aware of any, but doesn't any council member have any non-refuse related correspondence emails they would like to read into the record this evening.

JON VAN HARLINGEN: Mr. President?

PRESIDENT FALQUETTE: Yes, Councilman Van Harlingen?

JON VAN HARLINGEN: I have nothing to read but I've heard nothing positive about it.

PRESIDENT FALQUETTE: Your back on refuse correct?

I talked to the health department rules are going to be pretty much what you might expect; face mask is 100% required. So, if you don't want to, can't, don't feel like, no excuses, if you don't want to wear a mask please continue with the online meeting presence. If you're willing to wear a mask we're going to maintain 6-foot social distance throughout the entire room and when they filled up that's going to be limit. This is probably going to pose some kind of problem but I'm willing to try it to have some of face-to-face contact. So, we will certainly find out if the press, Mr. Trumble and Hunley would like to attend in person. Will make accommodations for them and the council people and we will move forward from there. We'll see how it works. We got a few bugs I'm working out with IT. There are now cameras in the council chambers, so the people in council will be broadcast similar but different then we are now. We all have our own personal camera right now, this is going to be more of a group camera. And we'll see what happens. I'm sure just like the first time we did electronic vote, the first time we did an online meeting it was rough. First time we did executive session we made a few bumps in the road. So, I'm hoping I'm looking forward to that meeting. So, anybody on council has a

question about it. I want...I'm trying to get a headcount so I know about how much room we need so that we don't over stack our six-foot clearance that's my number one concern. And I think at this minute I think we're just going to start just with council people and ask the administration to hold off at least on this first meeting and then we'll see how it moves forward from there and hopefully this whole virus thing will continue to get better. Now does anyone have anyone else?

JAMES WEINER: Mr. President if I could make a comment.

JAMES WEINER: Just a reminder to council people as we transition and slowly start working our way back into council chambers, you will still be from now on voting electronically. So, it is important that you do bring your laptops if you are going to be in council you just stop using zoom on your laptop. You'll be only utilizing the voting software. We have put in a wireless access point directly in council chambers. It has a great capacity, so we won't have any issues there. I would also ask at least for the time being to make sure your laptop is fully charged prior to a council meeting because I have not worked out with maintenance yet getting power plugs around for everyone's laptops during the meeting. I'm sure that's coming, but I just want to make sure you guys are prepared to be able to get through the meeting and then be able to vote. That's all I have sir, thank you.

PRESIDENT FALQUETTE: Thank you for those reminders because I knew all that but I did forget. Ok, I'll not entertain a motion to close the meeting.
