REGULAR COUNCIL MEETING April 19, 2022

The second monthly meeting of Mansfield City Council met on Tuesday, April 19, 2022 at 7:17 PM in the Council Chambers of the City Building.

The Pledge of Allegiance was recited by the audience.

Eleazer Akuchie led the audience in prayer.

ROLL CALL: The following answered present at roll call: Burns, Meier, Akuchie, Davenport, Diaz, Moton, Zader, Scott and Falquette.

There being no objections, the reading of the Journal and Correspondence was dispensed with.

PUBLIC COMMENTS:

PRESIDENT FALQUETTE: Anyone that wishes to speak to council. We have Mr. Esther McNeil this evening. Mr. McNeil if you'd like to come forward, get your 3 minutes.

EASTHER MCNEIL: I wrote something down, so it won't take me 3 minutes. First, I would like to know what percentage, from the hood, is set up for low- and moderate-income people in the city of Mansfield? I would like to get a list of that. Next, is it true that down by Ideal Electric that someone bought the land and is going to put some housing condominiums down there? Do you know anything about that? Ok, guess not. All job applicants, regardless of race, are harmed by criminal records. A lot of them can't get places to stay. So why can't the City offer some of these people that's in jail that gets out, offer them some kind of job? I mean they can cut grass. They can do something. Instead of just letting them out. That'd help them and their family. And also create something for society. Instead of just letting them sit in jail. Next, I think I spoke about this before. Trash...left on the sidewalks. You got cans, well mostly plastic. When they running over trash...weeks sitting on the sidewalk. Cats, groundhogs, raccoon...they just tear the package...tear em up. It's all over the street. Two blocks from the city building, go down Diamond. Come on. Some of them people you got in jail should be picking up trash...could pick them up. If you pay 'em.

PRESIDENT FALQUETTE: About 30 seconds Mr. McNeil.

EASTHER MCNEIL: 30 seconds?

PRESIDENT FALQUETTE: Yep.

EASTHER MCNEIL: Alright. Why don't the city do something about these lights that are out? They was supposed to change the lights years ago. Take the old yellow lights out and put the white lights. Go down some of these streets. Ain't got no lights. The light poles are there, but no lights. Sorry I have to cut it short. But I had a lot to tell ya.

PRESIDENT FALQUETTE: Thank you Mr. McNeil. Alright. Any committee reports? Mrs. Zader?

STEPHANIE ZADER: I guess this would be the appropriate time to ask. Not necessarily a committee report, but I have something...a question from the public for updates. An update on the...where we are on

the dry damn project and the fireworks laws. So, I don't know if the administration could speak to that, to update on those or not. That's an email I received.

MAYOR THEAKER: Bob are you still on the zoom call?

ALOMAR DAVENPORT: No, we decided to...

MAYOR THEAKER: Well he was on for a little while

ALOMAR DAVENPORT: Oh, he was? Ok

MAYOR THEAKER: Because he texted me because he was on.

ALOMAR DAVENPORT: Ok.

STEPHANIE ZADER: If not, I guess if we could have an update for them at the next meeting.

MAYOR THEAKER: Sure, we can do that.

STEPHANIE ZADER: Um, and then Mr., if I could speak to what were doing with NECIC as I did last meeting about the trash. We are...the Parks Department and the Codes and Permits Department have partnered with NECIC and the TANIF program to help put teenagers to work cleaning up trash around our city. So that is being addressed.

PRESIDENT FALQUETTE: Thank you. As far as communications. I got a certified mail from the public utility commission. It is a CD, if you have the ability to read it. It's 250 page...55-page pdf document. Columbia Gas is asking for change in how much they get paid. And this is the workings of their response. Their open to public comment. So, if anybody's interested, we can figure out how to get it to you. But it's right there. Alright. Anybody...Ms. Moton, go ahead.

KIM MOTON: Yea, two things again about the trash. Because at the last neighborhood watch meeting that we had on the Hedges Street. I just needed to mention that again but it has been addressed. But the other thing with the Cherry Hill neighborhood watch was about the fireworks as well. And making sure that there's a certain time that's set for fireworks to be displayed. And it was also stated they wanted to make sure it was done before 12, you know midnight. And not so much with the actual fireworks that went above the homes. They just wanted it to stay something small. So, I wanted to make mention of that as well. Just something, you know, little sparkles or something that is just not so loud. And draws so much attention so.

PRESIDENT FALQUETTE: Anything else? Mr. Scott

PHIL SCOTT: Mr. President. If I also might address something that Mr. McNeil stated. As far as streetlighting, anybody can get on the Ohio Edison and report a street light being out. I've done it. If you notify your councilman, they can do it. You can do it. Anybody can get on the Ohio Edison website and report a street light outage. I've done it and it's been fixed.

PRESIDENT FALQUETTE: That's correct Mr. Scott. There also was a group that went around and marks poles with pink ribbons. There's over 100 poles identified and their working with the City Engineering office and Ohio Edison to get those corrected. Anyone else? Mr. Mayor?

MAYOR THEAKER: No, Mr. President, at this time I have nothing.

PRESIDENT FALQUETTE: Thank you Sir. Mr. Ramey?

DIRECTOR REMY: Nothing, sir.

PRESIDENT FALQUETTE: Mr. Brown?

CHRIS BROWN: No thank you sir.

MAYOR THEAKER: I do have a comment from Bob.

PRESIDENT FALQUETTE: Oh, a comment from Bob. Back to Mr. Mayor.

MAYOR THEAKER: I asked him real quick and he just answered. He said that we are under a contract for the design of the dry dam and they're designing it right now.

PRESIDENT FALQUETTE: Thank you Mr. Mayor for that quick update about the dry dam. And back to Mr. Brown. Sounded like he might need something.

CHRIS BROWN: Yea, no thank you sir.
