

REGULAR COUNCIL MEETING April 2nd, 2019

The first monthly meeting of Mansfield City Council met on Tuesday, April 2nd, 2019 at 8:10 PM in the Council Chambers of the City Building.

The Pledge of Allegiance was recited by the audience.

Councilman Lawrence led the audience in prayer.

ROLL CALL: The following answered present at roll call: Falquette, Van Harlingen, Jefferson, Lawrence, Taddie, Bryant, Mears and Scott. Rock was absent

There being no objections, the reading of the Journal and Correspondence was dispensed with.

PRESIDENT SCOTT: Are there any Committee Reports? None.




