REGULAR COUNCIL MEETING May 4, 2022

The first monthly meeting of Mansfield City Council met on Tuesday, May 4, 2022 at 7:54 pm in the Council Chambers of the City Building.

The Pledge of Allegiance was recited by the audience.

Eleazer Akuchie led the audience in prayer.

ROLL CALL: The following answered present at roll call: Burns, Meier, Akuchie, Davenport, Diaz, Moton, Zader, Scott and Falquette.

There being no objections, the reading of the Journal and Correspondence was dispensed with.

PUBLIC COMMENTS:

PRESIDENT FALQUETTE: Anyone wishes to speak with council, we've already had you come forward. We have at least three people left. Betty Palmer Harris or was she with Deanna West-Torrence? Is she right here? Alright, are you trying to get up here Betty? Because we were going to move the microphone for you.

AMY YOCKEY: I think her daughter was going to speak for her. Yea her daughter is going to speak for her.

PRESIDENT FALQUETTE: Ok...ok. Is this Betty right here?

AMY YOCKEY: Her daughters first.

PRESIDENT FALQUETTE: Thank you, if you could state your name and your address. There's a button on that microphone, if you press that it will light up a little bit. Right in the middle in the front. Yep. And then you can speak. You got three minutes.

LATONYA PALMER: Ok. My name is Latonya Palmer. However, I'm speaking for my mother, Betty Palmer-Harris, about the community center. So, on behalf of Betty Palmer-Harris who feels that we need a community center on the North End. I don't have my glasses...so what she's saying basically is a community center is beneficial for all age groups and that is where you have after school programs. Which deters at risk youth from crime. It provides a safe, constructive environment. The spaces are productive for all age groups. I'm nervous and shaking...I cannot read this. For all age groups and it builds fiscal and mental wellbeing for everyone.

PRESIDENT FALQUETTE: Thank you Latonya. Deborah Mount?

DEB MOUNT: Deborah Mount, 114 Cliffbrook Dr. Two things. First on Bill 75 of the adoption of the ordinance pages. I was concerned last week when I first saw it that the attached ordinance pages amendment, they were no where to be found digitally online. So therefore, it was not possible to know exactly what was being changed. I started making calls last week trying to get an answer. Today I still hadn't figured anything out. I stepped it up, eventually called the law department to find out specifically what was being changed with the fireworks stuff. The person who answered the phone said she didn't know and no one was in the office that could tell me. This stuff was supposed to be on file there. City Council

was not able to get anything either. I'm just concerned even if there is an answer as to what this changed to. There's talk of letting the citizens know what is happening before a vote. And we can't even find the stuff in advance to read. It's not online. I would hope you would, in the future, do better about actually letting us know what it is your voting on before you vote. Because I know your planning on voting on this tonight. Secondly, wanted to address the parks levy. The voter's rejection of the tax increase did not really surprise me. The City's' Parks Department was cut after the 2008 downturn. And 2013 the City asked voters to dig into their pockets for the pride tax increase. You told us then, the City officials at that point, told us that 22% of the pride tax designated for parks would be used for capital improvements and major repairs to park facilities. Once passed, it was instead used for personnel and day to day operating costs like mowing. The Parks Department has still no returned to being funded by the general fund, as it was in the past. Now since the pride parks revenue is not being used for capital improvements and major repairs that were missed. The parks have fallen to such disrepair, you again asked voters for another substantial tax increase. Voters are skeptical. I know some of the sentiment from voters in my area feel that the focus has been on the north end and they feel unheard and forgotten. But I would offer that your biggest hurdle is the message you have conveyed for a decade to the residents. Those in charge of the city's purse string, do not care about the parks. At least not enough to fund them with the revenue you already have. The voters have bailed you out once, and you didn't do what was promised with the revenue. So, they have reason to be skeptical. Tonight you are planning to give over \$2.8 million of ARPA money to outside entities. There is also an unallocated balance of \$6.1 million. You are using \$3.75 million for the foundation of this building. So, it seems highly likely it could be used for other deteriorating city properties. Additionally, the city's most recent finance report published online shows an overall cash balance of \$89 million and the unencumbered cash balance in the general fund being over \$5.7 million. You have numerous pools of money, but what the voters see is that you would rather sit on that money or give it away to outside entities before addressing the dire problem the negligence has created. Before you return to the ballot you really need to reevaluate your priorities. Thank you.

PRESIDENT FALQUETTE: Thank you Ms. Mount. Mr. McNeil, are we coming forward tonight?

EASTHER MCNEIL: Mr. Spon, how you doing? Nice to see you. Alright. I'ma try to be here...oh don't take that off my 3 minutes. I jotted down a few things. I left my...oh here they are, crap. I'm going to talk about the trucks coming down Park Avenue turning on Diamond. We got 53 footers coming that way trying to make that turn. It's stupid. You should never changed that light like that. It's bad. Mr. Where's that Bowers...whatever he's gone. Well anyway, you need to look into that. Ok, it would be nice if the city would put turn lights out there on Park Ave West and Home Road. We get a lot of traffic back and forth. And I come that way and I see people running the lights because there's no turn light there. You need to look into that. Speed bumps on East Arch Street. You tell me you can't put speed bumps on Arch Street. That's a bunch of crap. I'm telling ya. But you got speed bumps on landings out here. Other cities have put speed bumps in. Akron put speed bumps in. This is who Mansfield should be following, Akron, not Columbus. You know I'll donate \$100 to the city if they would put cameras to catch speeders on E. Arch Street. And after I donate the \$100, for each speeder give me back \$10. Trash containers, you need to take that off the books. About because there contained. Bags are contained. But animals gets in them. You need to change that and put trash containers that are in plastic trash containers not just in bags laying on the sidewalks. I just went to the 12th grade. I mean I could figure that one out. You should make sure that if you put the trash out, its in a container not a bag as a container. In your law books you got bags as containers. You need to take that off. And add hard containers. Something like that. That would help the city. Ok.

PRESIDENT FALQUETTE: Thank you Mr. McNeil. That's right on schedule.

EASTHER MCNEIL: Alright.

PRESIDENT FALQUETTE: Alright

EASTHER MCNEIL: Good thing I wrote stuff down.

PRESIDENT FALQUETTE: That helps a lot. Tremendously Alright, committee reports, once again

anymore? Mr. Mayor?

MAYOR THEAKER: No Mr. President, I have nothing.

PRESIDENT FALQUETTE: Mr. Director?

DIRECTOR REMY: I have nothing, sir.

PRESIDENT FALQUETTE: Mr. Law Director?

JOHN SPON: I have nothing, thank you.

PRESIDENT FALQUETTE: Thank you gentlemen. Proceed with legislation. Any late bills tonight Mrs.

LAURA BURNS: No, there are none.
