

**REGULAR COUNCIL MEETING
May 17, 2022**

The second monthly meeting of Mansfield City Council met on
Tuesday, May 17, 2022 at 7:26 pm in the
Council Chambers of the City Building.

The Pledge of Allegiance was recited by the audience.

Eleazer Akuchie led the audience in prayer.

ROLL CALL: The following answered present at roll call: Burns, Meier, Akuchie (excused 7-0), Davenport, Diaz, Moton, Zader, Scott and Falquette.

There being no objections, the reading of the Journal and Correspondence was dispensed with.

PUBLIC COMMENTS:

PRESIDENT FALQUETTE: Speak before council. Let's look at the list. We have Mr. Brian McAfee, I believe, from the fiber project. Is he available? And would he like to speak? If you could state your name and your address Brian. And there's a button on the bottom of that mic. There you go, you're on. Three minutes if you can.

BRIAN MCAFEE: Absolutely. I'm Brian McAfee with Omni Fiber, 441 Vine Street in Cincinnati Ohio. We're here to let the council know that we have selected your city as one of our cities were going to build fiber optic telecommunications to through out the city. Which will provide your residents and businesses with another option, full 100% fiber. So, they'll have the benefit of faster speed, better pricing and better reliability. We expect to begin construction on our project after our design phase and construction should begin sometime this summer. And based on your size of city, we expect that construction process to take place for about 9 months to a year. Any questions?

PRESIDENT FALQUETTE: Thank you Mr. McAfee.

MAYOR THEAKER: Mr. President?

PRESIDENT FALQUETTE: Mr. Mayor

MAYOR THEAKER: If he could just also include what he's, you know that its going to be competition and you're going to provide internet and television and every single option that's there for that.

BRIAN MCAFEE: Thank you Mr. Mayor. Yes, we are a full spectrum broadband service. Meaning you'll be able to have all complimentary services not just internet at faster speeds, up to 2 gigabits per second. Synchronists, up and down. But you'll also have video product and phone service.

PRESIDENT FALQUETTE: Very good. Does any other Councilmembers have questions? Mrs. Zader

STEPHANIE ZADER: Do we have contact info, your contact info?

BRIAN MCAFEE: Yes, the Mayors office has contact info. Happy to provide that to anyone that needs it.

PRESIDENT FALQUETTE: Alright, Ms. Moton.

KIM MOTON: Are you looking to establish an office to better provide for our residents?

BRIAN MCAFEE: Our call center will be located in Oxford Ohio. So, we will be Ohio based. There may or may not be a local presence because most things can be done via the internet.

PRESIDENT FALQUETTE: Mrs. Meier did you have a question?

CHERYL MEIER: I was just going to make the suggestion that you give your name and information to our clerk over there so she's got it.

BRIAN MCAFEE: Amy has it. Thank you.

CHERYL MEIER: You're on it. Thank you.

PRESIDENT FALQUETTE: If there's nothing else, we'll let him go.

BRIAN MCAFEE: Thank you.

PRESIDENT FALQUETTE: Thank you sir. Deborah Mount. Well she was there a minute ago. Oh, there she is. I didn't realize it was that hard to get up here. Go ahead Ms. Mount.

DEBORAH MOUNT: Deborah Mount, 114 Cliffbrook Drive. There was a few references made when you were talking about fireworks to 9 days. And I think Director Brown touched on that briefly, that its probable a bit more. According to the state law that I pulled up there's 21 days. So, I'm just hoping that you can sort through those and figure out what is proper locally and what is in excess. Also, I'm hoping you can clarify whether restrictions and state law will stand. Such as not shooting them off from a roadway. Thank you.

PRESIDENT FALQUETTE: Thank you Ms. Mount. And Mr. McNeil this evening.

EASTHER MCNEIL: I got a couple questions. I jotted something down. What's the duties of the council person at large?

PRESIDENT FALQUETTE: Remember, just go ahead keep going Mr. McNeil. We'll see If somebody can answer it at a later time.

EASTHER MCNEIL: And some people asked me about the Parks Department. They want to know what are they doing with the Parks Department. Gettin rid of parks. Fixin parks up or what. That's another question. Ok and...anyone look into the garbage can incidents yet? About putting the bags on the sidewalk. Last meeting I was here, I asked that question. About people putting their trash in the garbage bags and sit them on the sidewalk. I guess not. How long I got now? What about the absentee landlords? Especially ones that live in New York that have buildings here they rent to the people. Who do you see about that? Law Director, who do you see?

PRESIDENT FALQUETTE: Mr. McNeil all you can do is address me and tell us your concerns. We understand you have a concern about absentee landlords.

EASTHER MCNEIL: Some other people brought this to my attention, absentee landlords, living in New York. They can't get anything done. You talk to people, the managers... the managers wanna boot em out. Just like in Cleveland. They want to boot em because they ask something to be fixed. I guess maybe, the next time I come, you guys will have some answers to some of the questions I just asked. I asked em. I'll ask the Mayor. I'm putting this in your lap. Get on em. You're the boss. Get on em. Thank you.

PRESIDENT FALQUETTE: Thank you Mr. McNeil. That's our public comment for this evening. Committee reports, Mrs. Meier.

CHERYL MEIER: Thank you sir. I would just like to make an update to the Parks Committee. We have, Mark Abrahams and I met with Stan Jefferson the Superintendent for Mansfield City Schools. I actually

PRESIDENT FALQUETTE: That's very good news Mrs. Meier. Any other committee reports? Alright, would the Mayor like to address Council?

MAYOR THEAKER: No Mr. President, I have nothing.

PRESIDENT FALQUETTE: Public Works Director Remy?

DIRECTOR REMY: I would. I want to as the Safety Service Director, acknowledge and recognize that this week is National Law Enforcement, Police Law Enforcement week. And as some of you were here yesterday, there is a memorial on the second floor for officers lost in the line of duty in the Mansfield Fire...Mansfield Police department. There is a proclamation that's been put together, and was put together for National Police week. And I will take a few minutes here to read.

PRESIDENT FALQUETTE: Thank you Director Remy for calling our attention to this week to consider our fallen officers.

STEPHANIE ZADER: Mr. President if I may suggest that we take a moment of silence for those officers

PRESIDENT FALQUETTE: Thank you for your suggestion. I'm sure we should take a minute. Director?

CHRIS BROWN: No thank you sir.

PRESIDENT FALQUETTE: Alright. Mrs. Burns anybody bring late legislation this time.

Each of these three parcels lies over two separate zoning areas, R-2 and Multifamily. And so just for the sake of being completely accurate, this should read amending. And then down where it says Zoning Classification MF (Multifamily Residential District) and R-2 (Residential District) to Classification I-2 (General Impact Industrial District). So just for sake of complete clarity...and this information was presented at City Planning Commissions. So again, I apologize, I'm not sure where that got left off but its not any kind of major change. It is just for being specific.
