

**REGULAR COUNCIL MEETING**  
**June 7, 2022**

The first monthly meeting of Mansfield City Council met on  
Tuesday, June 7, 2022 at 7:37 pm in the  
Council Chambers of the City Building.

The Pledge of Allegiance was recited by the audience.

Eleazer Akuchie led the audience in prayer.

**ROLL CALL:** The following answered present at roll call: Burns, Meier, Akuchie, Davenport, *Diaz (excused 6-0)*, *Moton (excused 6-0)*, Zader, Scott and Falquette.

There being no objections, the reading of the Journal and Correspondence was dispensed with.

**PUBLIC COMMENTS:**

**PRESIDENT FALQUETTE:** Anyone to talk to council tonight? Mrs. Mount, would you like to come forward and talk about your topic this evening. Three minutes of course.

**DEBORAH MOUNT:** Deborah Mount, 114 Cliffbrook Drive. All of you should be aware, but our neighborhood has been asking for sometime that Shot Spotter be expanded. We obviously don't know if it will include our area, probably not, but there's a lot of support for this to be expanded. So, request that you recall thee citizens request and you approve this and continue into the future to look for ways to keep and expand the technology. And then one other thing that came to mind while the claims committee was going on. There was a reference made to fixing a reported problem within 72 hours. March 7<sup>th</sup>. I fell on the uneven concrete on the first-floor entrance, and did get hurt. I paid my own medical, and in retrospect I have wondered if I should have filed a claim because it still has...it's in the same condition. Hasn't been coned. Hasn't been taped. Hasn't been smoothed out. So, it just makes me wonder, it's been way more than 72 hours and the city didn't seem to take that incident very seriously. Although they were immediately aware that it occurred. So, I'm hoping that some consideration will be given to the city's liability. Especially in situations like that when there are injuries. Thank you.

**PRESIDENT FALQUETTE:** Thank you Ms. Mount.

**PRESIDENT FALQUETTE:** Are there any committee reports this evening? Would the Mayor like to address council?

If you peruse the Next-door app., I'm sure you've seen the continual thread of people all round ward 2 to the Ohio health neighborhood and to Lexington Avenue to Cline to Marion, just everywhere, commenting that the commercial grade fireworks are a continual bombardment throughout June to September. 4th of July is the longest 2 weeks of the year.*

*Do other ward council members consider the opinions of their constituents? Or do they just vote their opinion? Personally, I'm quite tired and frustrated pleading the wishes of this area. Others need to contact others, not just the police. My neighbors are willing to let those fireworks hinder their peace. No one is saying that fireworks can't be shot off but, it's continual, commercial grade, irresponsible behavior that infringes on their neighbors' good will.
