REGULAR COUNCIL MEETING June 21, 2022

The second monthly meeting of Mansfield City Council met on Tuesday, June 21, 2022 at 7:11 pm in the Council Chambers of the City Building.

The Pledge of Allegiance was recited by the audience.

Eleazer Akuchie led the audience in prayer.

ROLL CALL: The following answered present at roll call: Burns, Meier, Akuchie, Davenport, Diaz (on zoom for meeting), Moton, Zader, Scott and Falquette.

There being no objections, the reading of the Journal and Correspondence was dispensed with.

PUBLIC COMMENTS:

PRESIDENT FALQUETTE: Alright, let's see. You're going to grab the sheet. Looks like there's one name minimum on there, two! Mrs. Cathy Cutlip-Wills this evening. You catch...yep perfect.

CATHY CUTLIP-MILLS: I apologize, it's actually Mills. My handwriting is sometimes awful.

PRESIDENT FALQUETTE: Oh, that's right. Thank you.

CATHY CUTLIP-MILLS: Thank you so much for the opportunity to come here this evening and share with you. My message is kind of two-fold. And this is a fun type thing. First of all, I would like to personally invite all of you to come to the Richland County Fair over all anytime during the week. But especially on Wednesday August 10th at five o-clock we have a pie auction. And I would like to invite you to come out and bid on the pies. If you represent a company, they can bid on the pies as well and honor our bakers. And if you notice in your packet that I handed out, there is a flier. And I would ask a favor if you could please put that flier, announcing the pie auction it's the second document, up on any bulletin boards. Or anything you have access to including your churches and where ever you might travel. It would really help us out. And last but not least, I would like to invite all of you to bake a pie. To get involved. And if you don't bake, then find someone who does. You do have to be a member of the Agricultural Society. It's a \$25 membership. But you get seven passes for the fair. So, you can bring your family and they can use those 7 passes. You can come every day and use the pass. However, you would like. It also until entitles you to vote on those individuals who are running for fair board. And that election takes place on that Friday during the afternoon. So that would be an opportunity to come out. Now why should you bake a pie and get involved? If you notice on the front page, which has a pretty nice big pie on it, there are down at the bottom there are 10 categories listed. And you can bake a pie in four of them. Cuz you can only enter four pies. And they cannot be anything that has to be refrigerated. Because we do have the pies out. We start registration with the pies at 10 in the morning. It is over at 2 in the afternoon. And we judge at 2 or 2:30, I'm sorry. I have a panel of undisclosed judges, I keep that anonymous on purpose, who judge the pies. And then in each category there is a first-place winner. Each of those individuals receive a blue ribbon and then overall then I have a panel of three judges, that are not part of the first one, who judge those top ten pies. And they in turn will pick a grand champion. Oh, I'm sorry. I forgot Blue Ribbon winners also receive a \$4 prize. And then if you receive the grand champion, you receive a rosette and \$15. And if you have the Reserve Champion it's \$10 and a rosette. Now that's...you might say that's not all that much. However, I want to entice you just a little bit more. Because at the auction, every Pi is auctioned off and the baker will get 40% of whatever comes in for the pie and the 60% goes to the fair board for the upkeep of the Arts and

Crafts building. And the pies and everything due for the auction and for registration come into the Arts and Crafts building. And you can go in and download more applications if you have friends or relatives who want to make pies on the Richland County Fair website. And I would encourage you to do that. You can also have individuals who are 18 and under bake pies and enter them. I started thinking back and Covid just has me completely confused of when we did what. But I think it was in 20, either 2018 or 2019, we actually had a 17-year-old win the grand champion and it was awesome. She was so thrilled. So, encourage everybody to get involved with this. It's also a way of people knowing that you know there's a lot to the Richland County fair that you might be missing out if you don't come out. Oh, people outside the county can also become a member of the Richland County Agricultural Society. They can enter the four pies but they cannot vote. So that is where there is a difference on that. Any questions?

PRESIDENT FALQUETTE: Thank you Mrs. Cutlip-Mills.

CATHY CUTLIP-MILLS: Thank you very much. I appreciate being here. Have a good evening.

PRESIDENT FALQUETTE: Alright, Mr. McNeil.

ESTHER MCNEIL: I have a few questions. And statements. I see, I tried to jot this down. But couldn't get it. On the school that their, MYC whatever. The building that you're going to tear down. In the past, I guess they said there's a lot of asbestos in the building, alright. Now we take a step, look at all the people that died from cancer that went to that build...that school there. Somebody should look into that. How many people have died that went to that school? A lot of them have. They all had cancer. Id like to who's in charge of the trees that's been down and you bring them to the front. Can somebody tell me that? The trees that the wind broke down.

PRESIDENT FALQUETTE: We understand that your asking questions. But remember that the process here is you make your three-minute presentation...

ESTHER MCNEIL: Well somebody tell me. All they have to do is tell me who I talk to.

PRESIDENT FALQUETTE: There was a public...

ESTHER MCNEIL: Who do I talk to?

PRESIDENT FALQUETTE: There's...yea there was a public service announcement that the City's going to start picking that up tomorrow. And it has to be in the front of the yard or on the front curb. And that would be the property owner or persons responsibility to get it to the front curb.

ESTHER MCNEIL: Who do you call to say 'hey we have trees down in our neighborhood?

PRESIDENT FALQUETTE: We'll see if we can follow up with you on that Mr. McNeil.

ESTHER MCNEIL: Alright. Cuz on my street my house, next house, next house, they got something down. You know something? I wanna laugh because nobody took me seriously when I talked about the house on Arch Street that caught on fire. The guy had goats, chickens, all this. I came to Council and I spoke on that. Nobody took me serious. So, what happened? The guy got a fire. Poor chickens, three pigs, goats. One of the goats caught on fire. But nobody took me seriously. Same way up here on Eastgate. I asked the City about that. The apartments up there. Nobody took me seriously. So, what happens? Some lady lives up there. Somebody fell down through the ceiling. She calls the News Journal, and they went up and checked it. And Codes spoke on it. But when I spoke on it, nobody said a thing. Somebody better take me seriously.

PRESIDENT FALQUETTE: Thank you Mr. McNeil. Any committee reports? Mrs. Zader?

STEPHANIE ZADER: The owners of the Boot Life we're going to be here tonight but they had something come up. But July 1st they are having the Boot Life block party. And they are attempting to break the world record of line dancing, currently held by China. Which is strange to me. But they're working to do that. So, they are assembling people at the Mansfield Motor Speedway and they're working to get more than 20,000 people line dancing at the same time there. So, I will send the clerk's the information and ask them to include it in the communications after council.

PRESIDENT FALQUETTE: Thank you. Any other committee reports? Mr. Mayor?

MAYOR THEAKER: I have nothing.

PRESIDENT FALQUETTE: Mr. Remy?

DIRECTOR REMY: I will address the storm damage pick up. The city is going to go around and pick up storm damage per the press release in a similar manner that we do in leaf pickup during the fall. The property's...the City's going to be zoned out and we're going to pretty much follow that pattern. No one needs to call necessarily. There will be scouting done by the Street Department Complex to find debris. It will have to be put at the curb though. And it is supposed to be storm-related damage and not something that came down a year ago or two years ago and you just decided to put it out to the curb. It has to be manageable for this for the crews to pick up.

PRESIDENT FALQUETTE: Thank you Director. Assistant Director Law Director?

CHRIS BROWN: No thank you sir.

PRESIDENT FALQUETTE: Thank you.

CHERYL MEIER: President Falquette?

PRESIDENT FALQUETTE: Yes Mrs. Meier.

CHERYL MEIER: Can I piggy back off with Director Remy. I called Director...Mr. Brown...Steve Brown today at the Street Department. I've had several people asked about whether they could have their debris in receptacles. Whether it be a trash container or a compost bag and he said no he would prefer that they...that it was just on the curb. Less than 6 inches in diameter and 3 to 4 feet in length. So the question about the receptacles and the bags was something that people have been asking about so.

PRESIDENT FALQUETTE: Thank you for the clarification. Anyone else at this time?

DIRECTOR REMY: I will add that part of the reason for that is we have made arrangements with Richland County Solid Waste Facility to use that facility on Carnes Road to dispose of the waste, storm waste. They've been very cooperative with us and worked with very amicably. As always, you're not allowed to put plastic bags out there. You have to empty them. So, we have to make it as easy as possible to comply with their rules and regulations.

But uh, I just want to make sure the public understands that those trucks aren't going to be here for a while. So, if you could just kind of give us a quick up...like letting us know where we're at on that. And I think we need to hire more drivers to fill those, correct?

DIRECTOR REMY: First of all the trucks have been, to my knowledge, they have been ordered. Again the delivery date on them is going to be dependent upon manufacturers supply and demand and getting them here. We probably will not get...there's no way we're going to get them in 2022. We will get them in early 2023, probably at the earliest. As far as drivers, we have made a concerted effort to get CDL drivers. We've been working on that. We have had some progress on it to take care of them. To take care of those situations. Keeping in mind that only the 8 ton dumps, 8 ton dump trucks require CDL driver's. Which are two of the one's we purchased. The 4 of the ones that we purchased do not necessarily require CDL licenses to drive and operate. So we are working on it and we made a pretty good effort at getting CDL drivers in line and we are working on making it more enticing for current employees to get their CDL.

STEPHANIE ZADER: Thank you. I just wanted to make sure that the public was aware of where we're at on it. And there was no misunderstanding. So thanks for giving us an update.

So, we have to resolve some of those issues.

PHIL SCOTT: Ok, but that all said, have we collected any money in that?

DIRECTOR REMY: To my knowledge, no.

PHIL SCOTT: Ok.

DIRECTOR REMY: Because their trying to sort out which of the debts are actually collectible. That's what were working on.

PHIL SCOTT: Ok. Thank you.
