

**REGULAR COUNCIL MEETING**  
**June 15, 2021**

The second monthly meeting of Mansfield City Council met on  
Tuesday, June 15, 2021 at 8:14 PM in the  
Council Chambers of the City Building.

The Pledge of Allegiance was recited by the audience.

Councilman Lawrence led the audience in prayer.

**ROLL CALL:** The following answered present at roll call: Burns, (Meier was excused from meeting - vote was 8-0 yay), Van Harlingen, Davenport, Lawrence, Moton, Scott, Zader and Falquette.

There being no objections, the reading of the Journal and Correspondence was dispensed with.

**PUBLIC COMMENTS:**

**PRESIDENT FALQUETTE:** Now have an opportunity to come forward and speak to council tonight. We do have Mr. Lee Tasseff from Destination Mansfield and he is going to address council for a few minutes. Mr. Tasseff if you notice...yep...you don't have to get too close, thank you in advance.

**LEE TASSEFF:** No, Mr. President, thank you. My compliments on your technological advancements. I've never heard clearer dialog in all the decades I've been through here. This is amazing. Even her mic was picking up your stuff when you didn't have yours on. I wanted to come and give you an update before we go too deep into the summer time. I was online back in March this is pretty cool to watch this will try not to get distracted all of beer before and it was kind of fun to go forward again one of the things that we did you all got one of the first ones actually was our Visitor Guide and wouldn't tell you that after three months of having it being distributed I can tell you that it's being received well it having to be restocked faster than previous Visitor Guide which were ecstatic about the fact that the magazine more the lifestyle look it draws people in as opposed to the more tourism oriented when we had before so we that was a good outcome because we wanted to be at have a much more broad appeal and so far that seems to be working also we need to do network with a different group of talent to do some of the things we're about to do we park one of that one of the new Partnerships with Great Lakes publishing bigger Ohio magazine Cleveland magazine long weekend they do sit magazine is also do a lot of work but I up which is one of the things that Drew us to them and tell you that the partnership with them in conjunction with tourism Ohio starting to pay off as well make over Ohio magazine Kingwood Center what does pretty cool also they also published for the tourism Ohio State tourism office their tour plan you open up and look inside the cover of a Tearaway map for young ladies from Mansfield out shopping in downtown Mansfield made it on there so I can tell you it's working and having and having been in that pipeline makes it easier for us to get stuff published our images of been using their social media campaigns have been using some of their video campaigns we got new numbers partnership marketing Partnerships with tourism Ohio to make our money go farther last week and also a story storytelling campaign in conjunction with Kingwood tourism Ohio as well as coming up here shortly we did one last year but we didn't make too much use the photo shoots last year cuz everybody had masks on and it was not we don't want to wait until this year which we did we got several coming what we're doing is auditioning photographers to Great Lakes publishing we're getting the other photographers we will probably have close to three dozen new photo so we can put on our media library which is important going into next year especially with implementing a new community brand we've the refresh a lot of things I got to do a video on the bike trail in the works for its access to for Community every Trail has scenery but we've got

access to 4 communities and now Kingwood it was important to show that visually and moving from almost the first person point of view that's coming up soon we have had five loggers influences in here some total they've got well over a hundred thousand followers and that's just on Instagram Facebook and it multiplies a couple times to make sure we've got some more coming in as well but that's up that's up and running has been since I've been here in March we've invested in a couple of websites for improving their marketing capacity counts a lot of our members on marketing one of the unique Partnerships that occurred was with Richland County foundation work with him in the past but there is something called a Google AdWords grant program and if anybody's familiar with that is a grant program the Google puts out for 501 c 3 non-profit is thousand dollars of Google AdWords every month for a year so it's \$120,000 of advertising Google AdWords Works where people are searching for your website for what they're interested in. May find your website if some of those search words are in your homepage on your website you show up at higher in a ranking you can purchase those add words those words are which means you bid forms if you outbid others for him you go to the top of the list and you rank higher we wanted to do when we couldn't do it we wanted to do it with to partner with two of you have to have an agency that goes with this to create your campaign manage the campaign basically it's a good third one step removed from you but you tap into their marketing expertise we look at it as building the capacity of a couple of our remember we did that had a chat with the Richland County Foundation they said what if we created the grant program so more nonprofits to jump it well 7 more did Foundation jumped in there that was just approved Monday through the foundation board and now there's going to be 10 nonprofit so I imagine it's going to be 1.2 million dollars in Google ad word campaign helping tours are mostly tourism oriented non-profit Market to themselves and every time you think of anybody coming here for whatever reason anybody getting positive attention your leveraging that for the community so you got all that working for us as well as we asked to be included we're downtown Mansfield and RCBG our commitment to ongoing commitment to transfer order to adapt what we know how to do into traditional Economic Development so now you will be doing it for promoting downtown and RCBG will be using it at end in their realm which is kind of cool to 15 month Hiatus it's going to be back hopefully by Paul we know what that is been involved thank you 2 Covid has been good and bad with Kokomo's be bad but there's no good partnership came out of it one of them was pulling together with the group called count on me or see where first there was a campaign of the communicate to the community about protocol this one now is about vaccinations maybe you've heard the radio commercials are also on digital audio there's a digital campaign to maybe if you pulled up your website all that's happening now we are participant in it I don't think we have been with that group had it not been for Covid do it again good outcome from it we're happy to be a part of a contributing marketing expertise and some funds to it all end of the community it's kind of a blueprint for how to communicate the next time there is a crisis that fits with this with his group can do so again that's humorous and also counsel businesses had to do something different when you walked into a place with the business had to follow certain rules now those are gone if you're going out and because there's a lack of link is a labor shortage right now it's not meeting the demand it's out there have a silly a comment like little patience maybe you're a little earlier where you're going to enjoy yourself cuz I think the way the pent-up demand it was turned in our industry angry pent-up demand meaning they were ready to go let's go I think people crowded into places and realize the rest of us couldn't handle them at first starting to subside but if you go out have some patience and beyond that you've got one of our you guys get to the a honor actually about seeing our Visitor Guide first you're also getting there seeing or any reports first it just showed up in our office today so it just gives a recap of last year you'll see a lot of pictures of Boston Mass Richland County Area Chamber of Commerce did Richland County Strong fantastic idea it will go out and visit we visited dozens and dozens of our members let everybody know through social media post and it was Amplified through the chamber does as well if they were open for business they were taking care of the customers they were ready everybody come out that's what you see a lot of highlights we didn't do a lot of things we normally do last year lot of stuff we just been prepped for things were adding to this year and I can tell you that each month we get to do a little bit more and it'll be it'll be more fun going in going into the end of the year with feel a lot more secure about what's happening. And with that I'll close for any comments.

**JASON LAWRENCE:** I don't necessarily have a question I just want to make it comment. I got to get out finally and go to Kingwood Center and I was floored by what they've done since I've last been there was a building that you can pass that along and continue to form of course you could continue to promote that we have a demo Bill Jewell there and I'm glad that the trailing end in Kingwood of working together so that's I don't know if that was you or that was green

**LEE TASSEFF:** I do know but I got the bike trail people together with the king would people to make sure that they had the proper equipment for bench bike rack where to put the bike rack we backed up today we all need to talk and to do it so that was a part of our ongoing Pikesville stuff but yes Kingwood was our focus last year but we threw out tens of thousands of visitors guide with them on the cover cuz nobody used it was a a lot of money out the door but that's there was and we put it back on the covers like you guys get a do-over so first photoshoot has Kingwood end at the storytelling partnership is with Kingwood we got a digital marketing campaign partnering with them they're a part of the Google AdWords stuff so yes they big they get a redo and I'm much much bigger way than even we were capable of a year ago had Covid not screwed up our industry.

**DEBORAH MOUNT:** This is Deborah Mount 114 Cliffbrook my other concern I wanted to bring to your attention tonight is a few months back I had asked a question what happens to the remaining balance in the safety fund at the end of the year when this was particularly pertaining to when I heard that they were down I think 10 officers at the time now I think they're down 16 officers that should about 2/1 and 1/2 million dollars and I was asked where does the money go and person I asked didn't know so I asked the finance department pursued it further it goes back into the general fund my problem with that is there are two dozen native levies that are specifically restricted what the funds can be used for there is no way to trace the money from those levees once it is putting the fun to know exactly where it is going city does not have a mechanism in place to track and keep that money from going in vagina pain cuz that is not allowed for love you money to go into the general fund granted their reasoning from the finance department as well we substitute with real money from the general fund into the safety of fun so theoretically they're taking it back out however it would see right lady 0 if that was so because they only transfer to fill the gap which was not how it was supposed to work when the levees were forced to the citizens it was not supposed to be planting money coming that's what's happening there is money left over which tells me the city does not have a mechanism in place preventing the restricted Levy dollars from being put in the general funds to my request to you guys as to please put some place to protect the restricted dollars from being put where they are legally not allowed to go there's no proof that can be given to me as a citizen that the tax dollars are going where they legally have to go and I'm requesting with that be change so that we can know the tax dollars are going where they legally have to go thank you




