REGULAR COUNCIL MEETING June 18, 2019

The Second monthly meeting of Mansfield City Council met on Tuesday, June 18th, 2019 at 7:00 PM in the Council Chambers of the City Building.

The Pledge of Allegiance was recited by the audience.

Councilman Lawrence led the audience in prayer.

ROLL CALL: The following answered present at roll call: Falquette, Rock, Van Harlingen, Jefferson, Lawrence, Taddie, Bryant, and Mears, Scott was absent Lawrence made a Motion for him to be excused, seconded by Rock.

There being no objections, the reading of the Journal and Correspondence was dispensed with.

Public Comments: None

MONDAY DEADLINE

MR ROCK: I move with respect to Bills 19-127, 19-128, 19-129, 19-130, 19-140, & 19-141 that the rule requiring legislation be submitted by 4 PM on Monday be suspended and that Bills 19-127, 19-128, 19-129, 19-130, 19-140, & 19-141 be allowed on the floor this evening, seconded by Mr. Rock and passed by vote: Ayes: 6, Nays: 1 Opposed - Mr. Falquette.

DISCUSSION:

MS. TADDIE: Yes. Mr. President, would like to bring to the topic there has been brought to our attention and discussed outside of this chamber, a, quite a number of late bills, this session, as well as last session and that it does cut short the ability of the various departments to weigh in on due-diligence etc. Would like to bring that up for discussion, publicly, at this point. Mr. Falquette.

MR. FALQUETTE: This has been one of the things I've driven for a long time. We've got a rule set. We've got a Monday evening deadline, a week before, not yesterday, a week ago. Last week 60%, of the legislation brought forward, was brought forward late. Tonight, it's another 30%. I'm not sure any of these things are absolutely burning, at the same time, I don't understand why a little bit of preparation couldn't have gotten these on the floor in a timely manner. Once in a while we've got something that, literally, comes inside there that's really important, has a deadline, but so many of these things should be able to get inside of the normal work rules. And that's been my whole point the whole time. So, it's difficult for me to pass and keep... why have a rule if we're not going to use it? Thank you.

PRO-TEMP JEFFERSON: Is there any other discussion on this? I'd like to know, where is the break down? Can somebody tell me where the break down is that it's not getting in on time?

LAW DIRECTOR SPON: I think I can speak for our office. We currently encourage each of the departments or those that are responsible for Legislation to, please, please, please, get them in earlier and it's not unusual that our office is asked at the eleventh hour to prepare Legislation. I think it's just a matter that each of the departments or sponsors is just so extremely busy that they are doing the best they can to get them in. But, let me just say this that I agree with Council in terms of rule, we should recognize a weight to rule, but at the same time balance it in terms of efficiency. If we have the subject matter of a grant and we run the risk, in theory, of losing the grant, through some unexpected, extraordinary, or unforeseen event, it's best to move on it, accept the grant and then we have a binding contract to receive it. So, I agree with your general thoughts and considerations for the public Um, I guess there's just some things that I think, that I can't think of any type of any type of objection that would be in the best interest of the City, like a grant. I think a grant should be accepted. As long as there's not, as long as we know that we can meet a match or something like that. Matches, local match isn't a problem.

PRO-TEMP JEFFERSON: Well, I would, I would agree with your suggestion and what you're saying about grant money, but other times it might not be grant money, just moving money from one fund to another fund. I, Mr. Falquette, I'm in the same with you; I think they should adhere to the rule, and if they late then they have to wait an extra Council session. Any more discussion on this? Mrs. Taddie.

MS. TADDIE: Well, just to wrap, my thought on the process is, if it's coming in, in the middle of the week, after the deadline, maybe we should start thinking of it that they're really early for the next Council and you know, move on that basis and as it's been discussed, if there's a time sensitive issue on the table that I work in grant timelines all the time; you miss the deadline you don't get the grant, so I understand that there are moments when we have to make these motions to move, but we seem to be depending on it more and more as those order of business and we want to make it as definitely the exception. So, if we could, you know do our part to share that, uh, on down the chain and the departments as well. With that said, we did move, tonight, to move Bill 140 and 141 through for a vote.

PRO- TEMP JEFFERSON: Are you done Mrs. Taddie?

MS. TADDIE: Yes.

PRO-TEMP JEFFERSON: Mr. Lawrence.

MR. LAWRENCE: I'm sorry. No, I'm not sorry I'm sorry... laughs, I'm sorry for apologizing.

AUDIENCE: Laughter.

MR. LAWRENCE: I agree with my colleges, Mr. Falquette and Mrs. Taddie, um, but in the same sense there are some pieces of Legislation, I don't want to say weightier or of more importance, I think every piece of Legislation has its own life to it and I think we're all bright enough and smart enough to what's important and what's not important. What can be hurried and what can't be hurried. I just want us to keep that I mind moving forward, there are some big issues that come

before us that, in the past, what I've seen so far, in my five years of Council, we've slowed down or we've sped up, so, um let's also keep that in mind in moving forward.

MR. MEARS: If I may, make a comment?

PRO-TEMP JEFFERSON: Oh, Okay.

MR. MEARS: I agree with my colleges here, I think, the point is, that we see a lot of routine Legislation, things that come up that are regular, not emergencies that tend to get processed late, so I think, keeping mind, the emergencies, the impact that it would have if it was not accepted, yes, but for the most part, I think most of what we've seen are things that are not emergencies, that are just late in being handed in. So, my question for tonight is do we want to let it go for tonight because we're adhering a deadline that maybe the departments are used to us accepting late, and maybe impose a stricter guideline for upcoming Council meetings. That's something we might want to consider tonight.

PRO-TEMP JEFFERSON: Mrs. Taddie.

MS. TADDIE: I'm in agreement with that. I think you want to set standards and clarify that the slide is, that we've drawn the line in the sand and I'm not against moving these forward tonight.

CLOSING COMMENTS:

DIRECTOR SPON: Wanted to make one comment just for Council member's consideration. I understand the idea of reading each piece of Legislation three times, but I just throw this out as an example. We have, roughly, eight pieces of Legislation, that were read that were to be moved up for vote today, and I can't think of in any single instance a legitimate rational reason to delay not voting on them, as we did tonight. But, if you give three reading to everything that comes before you, then if we didn't pass these eight, you're going to add those eight to the agenda at your next meeting. The second meeting you're going to be up to adding sixteen. The third meeting you're going to be adding twenty-four, possible pieces of Legislation, that there may not have been a legitimate reason to, to delay. And also, we'll have to find out on any of these grants, is there a deadline, and we'll have to ask on every piece of Legislation is there a deadline.

PRO-TEMP JEFFERSON: Okay. Thank you very much. Mr. Falquette.

MR. FALQUETTE: Just in a quick rebuttal to that, it doesn't have to do with the multiple readings. It has to do with the preparation for the very first reading. The very first reading, we need to get our email on time and have proper amount of time to read it prepare for it; give us the opportunity to ask questions. We certainly, I don't see how that has anything to do with multiple readings, it has to do with the very first reading. And as far as these grants go I don't know, I didn't keep a tally, but multiple times annual grants come up, annual grants, and they're on the deadline. "I got to have this at this meeting, cause it's due on the 30th." It's the same grant every year, there's no reason somebody can't mark it on the calendar. That's where I'm coming from.

PRO-TEMP- JEFFERSON: I agree with you. Mr. Mayor.

MAYOR THEAKER: The only thing about those grants is, usually, the individuals doesn't even know until the week before or the week of. I mean that's how grants are. They may be the annual grant, that we may luck-out and get...but, sometime we don't know for sure that we're getting it until it's been awarded and that's when the crunch-time comes into play, sometimes.

MR. BRYANT: Wasn't that an example of that with the Victim's Assistant Grant, Mr. President? Mr. Mayor? That we had in October that happened, it came in the week before, it came in on that Friday and we had to rush it in or something?

PRO-TEMP JEFFERSON: I think most of our Council members, like Mr. Falquette said, get it in on time. They can read it and make a decision to push it forward, or two to three readings. I don't think that would be a problem. I think Mrs. Taddie and Mr. Falquette just wanted to put some information out there that there's too much slowness or late-time going on Mr. Mears even made comment to that. So, we just need to get that tightened up.
