

REGULAR COUNCIL MEETING
July 19, 2022

The second monthly meeting of Mansfield City Council met on
Tuesday, July 19, 2022 at 7:16 pm in the
Council Chambers of the City Building.

The Pledge of Allegiance was recited by the audience.

Eleazer Akuchie led the audience in prayer.

ROLL CALL: The following answered present at roll call: Burns, Meier, Akuchie, Davenport, Diaz, Moton, Zader, Scott (excused, 7-0 voted yes) and Falquette.

There being no objections, the reading of the Journal and Correspondence was dispensed with.

PUBLIC COMMENTS:

PRESIDENT FALQUETTE: If anyone wishes to speak, please come forward and state your name. If the Clerk will grab that. We'll have Mrs. Meier enter into the record a comment that she got that she wanted read that we will read at this time.

CHERYL MEIER: Thank you sir. This is from Sue Bishop at 70...I believe its 72 Leppo Lane. She has emailed and said "Thank you for taking my call this afternoon Ms. Meier. As you know I called to discuss the really awful weed conditions in what, could be, our lovely downtown.

I've lived in Mansfield all of my life (64 years) and love it here. I want to take pride in the appearance of our parks, schools, neighborhood and our downtown- yet they are all lacking. I have been on disability for a long time now, but if I were physically able I would be happy to get in line to help. That is just not possible for me at this point.

That being said the Public Square should be the highlight of any town including Mansfield. I've called the Mayor's office numerous times for several years about that ugly parking lot beside Reindeer Grill. If I am not mistaken it is owned by Don Nash or his affiliates. How awful! Have any of you just stood there and thought, what an eyesore? You cannot pass through downtown without seeing it. The parking lot, the sidewalks, the planters - awful; and by-the-way isn't there some ordinance about keeping fire hydrants clear of weeds, etc.? Good grief, just look at the hydrant on the corner of that lot. It is shameful!

Recently, I called the Mayor's office and suggested perhaps there could be some tax incentive, etc., offered to encourage that property owner to do something.

The sidewalks and planters up and down N. Main Street, Park Ave., and other side streets are being overtaken by weeds. Honestly, how do the existing business owners and entrepreneurs take it? Dumb move all of those years ago to put brick pavers in with no weed control. You know there are weed products on the market that could take of that problem. But let me guess: they might not be ecofriendly. There could be beautiful flowers in those big planters downtown in front of the banks. Need I even talk about the back side of the City Building/Police Station/Water/Sewer Dept.?

Then this past weekend we had a mega event at the Reformatory – INKcarceration. I hear in excess of 50,000 people were in attendance. How could that kind of exposure for our city NOT have prompted the Mayor and others to act to turn our downtown into a jewel? It was, and is, an embarrassment. I hear national media covered this festival, too. I can only imagine the many factors that a common person like me would not be privy to as it pertains to running and maintaining a city the size of Mansfield. Fiscal issues, personnel issues, etc., but come on: how could this have been allowed to be the "best foot" Mansfield could have led with for this event?

It is painful for me to try to wrap my head around the “appearance” that there is little or no civic pride among the leadership of our city. Someone please tell me I am wrong. There is so much wrong in our world, why can’t this somehow be right? I am not the only one who is disheartened by this. It hurts my heart to say it, but I can tell you: if I were looking for a new town and community to raise a family in, grow a small business in, or move a corporation too, it would not be Mansfield! You would not have shown me that you care enough about your own city to care about me! I do thank you for all the things that Mansfield gets right, but in this case, you can judge a book by its cover. Respectfully, Sue Bishop.”

PRESIDENT FALQUETTE: Thank you Mrs. Meier, on behalf of Sue Bishop. Pat Brook wants to talk about EMS. Pat if you haven’t been here before, there’s a button on that. You get to state your name and your address. You get up to 3 minutes.

PAT BROOK: Thank you sir. My name is Pat Brook and I am a retired registered nurse that worked in the emergency room and surgery over a span of about 47 years. I was also a member of Mansfield City Council a long time ago. My concern tonight involves the News Journals article about 4 Fire Fighters and I’m assuming they were EMT’s that were involved in the inappropriate medical care of a recently transported asthmatic patient to the ER. There’s a big problem here that needs looked in to. According to the paper disciplinary action was taken and two of them were fired. Their failure to document a primary assessment including; lung sounds, proper monitoring of vital signs, and the airway, were complicated further by improperly restraining the patients arms above his head and transporting him in the prone or flat position when he was having breathing problems. They also yelled at the patient and operated outside their scope of practice. They administered meds without the patients past medical history. I wasn’t there of course and I am going only by the News Journals article. I am here to say that the City and the County needs to reactivate the Emergency Medical Board Committee that was in effect when I was on City Council. To oversee the educational requirements, the standard of care, consistency with rules, and so forth. A board or committee with and ER doctor, um fire chiefs from various counties, an ER nurse, Safety Council Committee Chairman, Representative from the County Commissioners and an EMT and a Paramedic would be great for this board. Because none of this should have happened. The residents of Mansfield and Richland County deserve honesty, reliable, fast, efficient, and safe emergency medical care. Thank you.

PRESIDENT FALQUETTE: Thank you Mrs. Brook. Wayne Stevens on behalf of Mrs. Melton. It’s already set. And if you’d like to sit down, there’s chairs right there.

WAYNE STEVENS: How are you guys doing today? I’m speaking on behalf of Mrs. Melton.

PRESIDENT FALQUETTE: Your name?

WAYNE STEVENS: I’m Wayne Stevens.

PRESIDENT FALQUETTE: Thank you Wayne.

WAYNE STEVENS: Ok, I just want to give you guys a little bit of knowledge about her, this pretty young lady right here. Mrs. Melton she was a part of Westing House for 20 years. She also worked as a Corrections Officer at the prison for 13 years. She’s a mother of four from Mansfield. She was a part of the first several women to work aside the men in the correctional facility. Mr. Wayne McDowell, he fought for all the women and he won the ruling to have equal opportunity to work alongside the men. She’s in her eighties and she’s still raising grandkids. Mrs. Milton...

PRESIDENT FALQUETTE: I think you’re a little close. You can...

WAYNE STEVENS: Move back a little?

DELAINE WEINER: You can stand up.

WAYNE STEVENS: Is this better?

DELAINE WEINER: You can like stand up all the way

WAYNE STEVENS: Ok

DELAINE WEINER: It's fine. It'll pick you up.

WAYNE STEVENS: Ok

PRESIDENT FALQUETTE: Yea, it'll get ya.

WAYNE STEVENS: Mrs. Melton of 990 Larchwood requests that the City of Mansfield, vacate alley to her which the City of Mansfield has abandoned the last 50 years. And she has maintained this alley for the last 26 years. Which is located on Cal Street between the land parcels 2878 and 2879 and also 8930 and as well she is the only adjacent property owner.

PRESIDENT FALQUETTE: Anything else?

WAYNE STEVENS: No, that's it sir.

PRESIDENT FALQUETTE: Alright. So, we thank you for coming and appreciate you keeping it brief. The clerks going to provide you with a form. There's a form to fill out. And this can go right through Council at a future date. I don't have anything else for public comment so we'll close public comment at 7:28. Committee reports, Mr. Mayor?

MAYOR THEAKER: No Mr. President, I have nothing.

PRESIDENT FALQUETTE: Director Remy?

DIRECTOR REMY: I have nothing, sir.

PRESIDENT FALQUETTE: Assistant Director Brown?

JOHN SPON: No thank you sir.

PRESIDENT FALQUETTE: Thank you gentlemen. Let's proceed with legislation. Mrs. Burns, do we have any late bills this evening?

LAURA BURNS: Yes sir.

LAURA BURNS: I move with respect to all bills that come before council this evening that the rule requiring reading on three different days be suspended and that each bill be read one time by title only. Seconded by Mrs. Zader. The vote was taken and resulted as follows: Ayes: 7, Nays: 0

PRESIDENT FALQUETTE: Alright, let's get started here. Back to Mrs. Meier, 22-122.

CHERYL MEIER: Thank you Mr. President I... (background noise) are we good? Ok.

PRESIDENT FALQUETTE: We're good, my apologies.

CHERYL MEIER: I'm sorry. I move...uh...oh my gosh. It's been too long since we've been here, what am I supposed to be doing? (laughing) Yea, what...we...I ask the clerk read bill 22-122 for uh...to discuss.

PRESIDENT FALQUETTE: Right, the clerk will now read 22-122.

CHERYL MEIER: I'm sorry Shari. It's my first night.

DELAINE WEINER: Ok, it's been a long time since I've done this. And I have a lot to read here, so don't mind me if I mess up Shari. (David said something not picked up on the microphone) Ok, yea I know. That this Council, on behalf of the government and the citizens of the Mansfield community, is privileged to honor and pay tribute to Captain Shari Robertson upon her retirement, effective July 7, 2022 after 28 years of service with the Mansfield Division of Police.

Captain Robertson was appointed to the department and began her law enforcement career on August 24, 1994 and was promoted to Sergeant on February 14, 2005. She was promoted to the rank of Captain on April 3, 2014. She has been assigned to numerous areas within the Division including, Patrol Section, Community Policing, Traffic Section and the Office of Professional Standards/Training Section. Since April of 2014, she has served as the Commander of the Special Operations Bureau which includes Detective Section/Major Crimes Unit, Forensic Science Section, Neighborhood Impact Section, and the Office of Professional Standards/Training Section.

During her career, Captain Robertson served in various roles within the Division including Recruitment Officer, Public Information Officer, Intelligence Liaison Officer, OPOTA Certified Firearms Instructor, Field Training Officer, and Field Training Supervisor. For the past 8 years, she has served as the Division's Accreditation Manager for the Commission on Accreditation for Law Enforcement Agencies (CALEA) as well as the Ohio Collaborative Community-Police Advisory Board, the state's version of CALEA. She has been a Division grant writer/manager since 2008 and has accumulated approximately 11 million dollars in successful local, state, and federal grant awards for the Division over that time.

Captain Robertson earned a Bachelors in Business Administration in 2004 from the Mount Vernon Nazarene University and is a graduate of the 2012 Police Executive Leadership College. She is an OPOTA certified training instructor, a lifetime certified Crime Prevention Specialist through the Ohio Crime Prevention Association (OCPA). She has served as an OCPA District Representative, OCPA Secretary and was elected President of the Ohio Crime Prevention Association in 2007. She has co-chaired numerous

OCPA state training conferences and co-authored OCPA's Advanced Crime Prevention Specialist Training Manual and Curriculum in 2012.

Captain Robertson's retirement represents a loss to the Mansfield Division of Police, the citizens of this community, and culminates a career that has exemplified the best qualities of a law enforcement professional. We extend to her our congratulations upon her retirement and our heartfelt thanks for many years of loyal service. We wish her the greatest success and happiness in the future.
