REGULAR COUNCIL MEETING August 3, 2022

The second monthly meeting of Mansfield City Council met on Tuesday, August 3, 2022 at 8:03 pm in the Council Chambers of the City Building.

The Pledge of Allegiance was recited by the audience.

Eleazer Akuchie led the audience in prayer.

ROLL CALL: The following answered present at roll call: Burns, Meier, Akuchie, Davenport, Diaz, Moton, Zader, Scott and Falquette.

There being no objections, the reading of the Journal and Correspondence was dispensed with.

PUBLIC COMMENTS:

PRESIDENT FALQUETTE: We have one person, Debra Mount, to speak before Council on pot holes and something else. Ms. Mount?

DEBRA MOUNT: Debra Mount, 114 Cliffbrook Drive. Two things, one more, well three things. One more came up as I was listening. I wondered if, you can't answer the questions I know in this format, but if the City has come up with a way for the wording of the replacement pages to be online so that citizens and Councilmen can see exactly the changes. Specifically, what is being copied from state law and interspersed into city law. Cuz we would of seen what council passed with the state, the city. That came up several months ago and I'm just hoping a solution has been found with Walter Drane that can be reviewed in advance. Next on pot holes. I'm hoping Claims Committee can check into the system of documentation of reports. Because there is a pot hole/area of sunken road that I had reported twice in two months and as of a few days ago it was still not repaired. So, it's been well over the 72 hours. But I don't know if the Street Department has a way of properly documenting they've gotten reports and what is the City's liability when they've been informed by phone or the online form. And it hasn't gotten fixed, no ones been out. And then lastly on the discussion on the ARPA dollars I am hoping you will remember the citizens having turned down the parks levy and the sentiment I heard from some of the citizens was you already had money available for various projects. And you were choosing to give it to other entities instead of use it for the City's needs. So I'm hoping you'll consider the citizens concerns and use the ARPA money specifically to meet needs of the city first before giving it away. Thank you.

PRESIDENT FALQUETTE: Thank you Ms. Mount. Any committee reports?

STEPHANIE ZADER: Mr. President if I may.

PRESIDENT FALQUETTE: Go ahead Mrs. Zader.

STEPHANIE ZADER: For the claims committee can I address the concern that was just brought up?

PRESIDENT FALQUETTE: Yea, it sounds like a committee thing to talk about.

STEPHANIE ZADER: If you give me an address I'm happy to get that over to the service complex. They do have a system that they use to track reports of pot holes and stuff. And when we get claims our Law

Directors office does a great job of going through that and getting that documentation from them. You're always welcome to call me or text me if you see a pot hole and it hasn't been addressed or any other concern.

PRESIDENT FALQUETTE: Thank you Mrs. Zader. Any other committee reports this evening? Mr. Mayor, council comment?

MAYOR THEAKER: No Mr. President, I have nothing.

PRESIDENT FALQUETTE: Mr. Remy?

DIRECTOR REMY: I want to say, I've already indicated earlier this evening but we are currently actively in negotiations with all four unions. I ask councilman to refrain from discussing issue related to the CBA's with anyone, any employee, or anyone in an of the four unions. Their union reps, their union coordinators or their union officers. The HR Director and I have enough to do in dealing with the negotiations in and of themselves. And I do not want to create any type of basis for any ULP. Which is Unfair Labor Practice action against the City for inappropriate discussions about negotiated items. This is a reminder that the City has an administrative arm to deal with negotiations. We're doing that actively on a daily basis. Councilman are not a part of that equation, and should not be a part of that equation.
