

**REGULAR COUNCIL MEETING**  
**August 16, 2022**

The second monthly meeting of Mansfield City Council met on  
Tuesday, August 16, 2022 at 7:49 pm in the  
Council Chambers of the City Building.

The Pledge of Allegiance was recited by the audience.

Eleazer Akuchie led the audience in prayer.

**ROLL CALL:** The following answered present at roll call: Burns, Meier, Akuchie, Davenport, Diaz, Moton, Zader, Scott and Falquette.

There being no objections, the reading of the Journal and Correspondence was dispensed with.

**PUBLIC COMMENTS:**

**PRESIDENT FALQUETTE:** Let's see we have speaking before Council. Tonight, we have Esther McNeil. You're up first tonight for this section. You know all the rules. Thank you, Mr. McNeil.

**ESTHER MCNEIL:** I was sitting there and I jotted down some things. So I'ma go through these hopefully quick. The rule of kids with the basketball hoops, right there along the curb in the city. Somebody tell me, afterwards, what's the rule on that. The rule of pit...well not just pit bulls but dogs running around neighbor, especially our neighborhood. Had a mailman, nice guy, he was bit three times. So, he's not on our route now cuz of that. Ok, the City needs to look at the people that rent property but live out of the city. They don't care. Who do you see about the lights in the City that are out? Especially in our ward, 6<sup>th</sup> ward. This probably goes most of the City, trees that grow up on the side that the City planted years ago, covers...covers on the street. They in the lines. You got streets with bushes there, people have to drive into the street in order to see cars coming. Now what is the City bringing to the city that pays taxes? So, homeowners don't have to pay taxes so much. What kind of projects are going into the city? There going outside the City. But what are you bringing to the City? Some body need to look into that. **PRESIDENT FALQUETTE:** And a second? It's been moved and seconded to allow Mrs. Zader and Ms. Moton to abstain. Can we do that electronically? Alright...sure...we're going to do it electronically. Without Adrian standing here, it didn't click for me either. Ok. I don't think there's any further comment, so if we can vote. It looks like it's up there. To abstain. Alright, so that passes. So, we're going to do a revote on bill 22-137. It's already been moved and seconded so were just going to revote 137. Unless there's comment. It'd be a good time while were waiting if someone wanted. Alright, it's up there. Let's revote for the record here. Here we go. It passes 6 and 2 abstentions, no nay votes.

**AMY YOCKEY:** Good catch.
