REGULAR COUNCIL MEETING August 20, 2019

The First monthly meeting of Mansfield City Council met on Tuesday, August 20th, 2019 at 7:00 PM in the Council Chambers of the City Building.

The Pledge of Allegiance was recited by the audience.

Councilman Lawrence led the audience in prayer.

ROLL CALL: The following answered present at roll call: Falquette, Van Harlingen, Jefferson, Lawrence, Taddie, Bryant, Mears and Scott. Rock was absent Falquette made a Motion for him to be excused, seconded by Jefferson.

Committee Reports:

MR. BRYANT: Mr. President I have one, um, just for safety, um, we talked a few weeks ago again about the, hiring of um, our, um Mansfield Police Officers um, for private functions and whatnot. There is already a law on the books for that; already an Ordinance so um, I would like to bring that Ordinance forth to the Committee, umm, so that we can review it, nothing to pass, but to review, just to make sure that people understand that's already on the books and if there are any changes that need to be made I would like to the Committee's attention.

PRESIDENT SCOTT: So are you going to call a...

MR. BRYANT: I'm going to call a Safety Committee meeting next Council Session. Thank you.

PRESIDENT SCOTT: Okay. Any Updates?

ASSISTANT DIRECTOR BROWN: I do have a quick update.

PRESIDENT SCOTT: Yes.

ASSISTANT DIRECTOR BROWN: So. Many of you know, from time to time, I will update you on the House Bill # 49 Litigation that the City of Mansfield is part of, regarding the centralized collection of Municipal Income Tax. The last time I reported on this, we were waiting to hear back from the Supreme Court of Ohio and whether they would accept jurisdiction over the appeal of that case; they have accepted jurisdiction and they have narrowed it down to one question of Law, and it really get to the heart of the matter. It is, 'whether the home rule amendment of Ohio Constitution grants Municipal Corporations, a general power of municipal taxation' and then the question of, 'when a State Law engulfs that general power of taxation, would that State Law be unconstitutional?' So, we had previously discussed this and talked about how the Ohio Supreme Court would approach this case, um, thankfully they have kind of tackled the question head on and made it a matter of Home rule interpretation, um, and as just as a kinda

friendly update there is now a whole long list of proceedings. Um. There's twenty days to file the record of appeal process. Thirty days to file our brief. Twenty days for the State to respond. Um, another twenty days for us to respond to the State's response and then, the Supreme Court will set oral argument after that. Uh, in total we're looking, uh, between one hundred sixty and one hundred ninety days, before we might have an oral argument on this case. So, it will be awhile, probably before you hear from me again on an update, but, I'll always keep you updated.

PRESIDENT SCOTT: Thank you for the update!

MR. BRYANT: Mr. President.

MR. BRYANT: One more thing before Council, if you don't mind...we, uh, had that section in the Public Utilities Committee tonight, about the water bills. Um, I appreciate the administration bringing that forth. If I do receive high volume in calls regarding that department, or if any of us, we're going to find ourselves back here during that Committee, with the Chairman's permission, addressing the same issue. So, I hope that works, the new system works, if not we're going to be back here again.
