REGULAR COUNCIL MEETING October 4, 2022

The first monthly meeting of Mansfield City Council met on Tuesday October 4, 2022 at 7:19 pm in the Council Chambers of the City Building.

The Pledge of Allegiance was recited by the audience.

Eleazer Akuchie led the audience in prayer.

ROLL CALL: The following answered present at roll call: Burns, Meier, Akuchie, Davenport, Diaz, Moton, Zader, and Scott. Falquette was Acting Mayor during this meeting.

There being no objections, the reading of the Journal and Correspondence was dispensed with.

PUBLIC COMMENTS:

PRESIDENT PRO TEMP SCOTT: I believe we have a couple people signed up for public comment. I think Mr. McNeil was first so. Mr. McNeil if you would come up. I won't start your three minutes until you get up there.

ESTHER MCNEIL: Mr. Mayor...Oh! You look different. Well if you were running, I would vote for you. You came to the church. Nobody else up here did. But thank you. I got a couple things. First, I'd like to say if I was giving money to HUD, if I was in charge, I personally would not have given it. And she knows why. Another thing, a tree fell in my backyard, it was on city property. They made me pay to get it cleaned up. Ride along. I see you ride along. Do you take notes of all the trash or do you just ride along and talk to the person that's driving? Well answer to them. Mr. Smith...my times cut off. Alright, well I'm going to take 2 minutes. Water leak, Mr. Diaz. Up on Sherman. Sherman Estates. They got a water leak. Been up there. Need to look at it. Times up. Did anyone else in the neighborhood get a water about boiling the water? On the leak in our area. I asked some other people, they didn't get it. Our water leaks in the city are leaking all over. I don't know what your gonna do about it. Other than dig them up and fix them. You got a 100-year-old pipes, maybe 200 years old. And there busting all over. I know we got some money. We had money last year. 24 million dollars. I know we aint spent it all, cuz we didn't spend the money before. So, we need to fix these water leaks. 10 seconds? 20 seconds. I gotta ask you this cuz he was talking. on the Air Guard, did we do anything about that?

PRESIDENT PRO TEMP SCOTT: We have one other person signed up, Nancy Jones. You get three minutes to address council.

NANCY JONES: Oh, my name is Nancy Jones and I live at 1602 N. Stewart Road. And what else did you want? That's it? Ok. Ok, sorry. I've never been here before. I'm not a frequent flier. Anyways, what happened, is on June 14th we had that big storm that came through on June 14th. And the tornado came down through Bellville. Well I have rental properties all over Mansfield, ok? And I property manage for two other people in Mansfield that I take care of as if I own them myself. On June 14th I got a phone call from a tenant on 627 Springmill Street that she had sewage in her basement. Well I naturally first thing I thought of was just for the fact that it was a backed-up sewer line. When I get there, I was like "whoa". And I brought boots, like 18" boots. And I went to the place and I was like I couldn't get down to the steps and I was like "whoa". And she said she smells this overwhelming sewer. And anyways I was like floored on how much water was in that, or sewage was in the basement. It was raw sewage that had backed up into the basement. Well in the meantime I get a phone call from the lady who lives next door

and she told me there's water shooting, or sewage, shooting out of my driveway on 629 Springmill. Cuz I have 3 apartments there and it was shooting up like a geyser ok. And I took video, I have a video of it shooting up out of my driveway. And I was like "whoa". So, when I...so I...let me handle one situation at a time. Went to the 627. I couldn't get in there. I called Brads Drain Service. I said "you need to come over here".

STEPHANIE ZADER: Mr. President if I could. Sorry to interrupt but we actually made a decision on your claim that you filed.

NANCY JONES: Yea?

STEPHANIE ZADER: During the claims committee and we did make payment on your claim.

NANCY JONES: Ok.

STEPHANIE ZADER: So, they've shared with us the...what's happened and stuff, just to let you know. I didn't want you to feel like you had to go through that if you...and I can give you what we did with that if you would like. I can step out with you and let you know.

NANCY JONES: Ok. Ok...I've got it. Thank you for that because this is actually like my third time at this with, just to let you know. I didn't think about it when I wrote my letter out. But on 10 months prior to that I had the same situation happened to the same tenant who lost a washer and a dryer. She lost two dryers and washing machine on that incident on August of 2021. Two dryers and washing machine. No, I'm sorry one washing machine, one dryer. And I didn't lose anything. Well this last one because I had...I did actually have 3 feet of sewage, 3 feet in her basement. And she lost two dryers this time and a brandnew washing machine and then I didn't think anything about it. And a couple days later she goes I don't have any hot water and I'm like "gasped." So, I panicked and I'm like found out that I lost my hot water tank and I lost my furnace. And which my furnace just got put in 2 weeks ago. But when I...the thing I do have to say is when I went to the city and I talked to the guy in charge, very nice man. Talked to him. I asked him, I said what I don't understand this is like my third or fourth incident that I had with this situation with the same houses, with the same sewage backing up in my basement. The only thing that save my rental next door with 3 furnaces of 3 hot water tanks was because it was gysing up out of my driveway, okay. That's the only thing that saved those, because it didn't come in my basement cuz it was shooting out of my driveway. Okay but when I went down there to the...to the workers I found out that they have several workers that wait for emergency calls, okay. And I'm like why don't you guys send them out, since you're paying them to sit for hours, why don't you send them out on calls. I just this is why I said why don't you send them out on calls and use that money wisely. That was just an input.

PRESIDENT PRO TEMP SCOTT: Ok wrap it up real quick cuz your over time and Mrs. Zader will talk to you about the other claim.

NANCY JONES: But I just...I just ya know. They said they would put it on general maintenance to do it all the time now. Which I'm glad they did that because this has been an ongoing problem on that street. So I'm glad that they're taken care of it. I'm glad to take care of my claim. My tenant might be down here for a claim because she's lost thousands and thousands of dollars' worth of damage.

STEPHANIE ZADER: Well I'll step out and talk to you. One thing I do want to...one comment if I could Mr. President is that we don't just have guys sitting around doing nothing. So I just want to make that clear that our guys work very hard and stay busy and we can talk about that when I step outside.

NANCY JONES: Wellll...well. Ok.

PRESIDENT PRO TEMP SCOTT: Can you turn the mic off please? Ok, moving on. Mrs. Burns do we have any late bills?

LAURA BURNS: Yes sir.

PRESIDENT PRO TEMP SCOTT: Op, I'm sorry. Back up just a hair. Acting Director Mayor do you have anything?

ACTING MAYOR FALQUETTE: Nothing, thank you.

PRESIDENT PRO TEMP SCOTT: Director Remy?

DIRECTOR REMY: Nothing, sir.

PRESIDENT PRO TEMP SCOTT: Director Brown?

JOHN SPON: No sir. Thank you.
