

**REGULAR COUNCIL MEETING
October 18, 2022**

The second monthly meeting of Mansfield City Council met on
Tuesday October 18, 2022 at 8:23 pm in the
Council Chambers of the City Building.

The Pledge of Allegiance was recited by the audience.

Eleazer Akuchie led the audience in prayer.

ROLL CALL: The following answered present at roll call: Burns, Meier, Akuchie, Davenport, Diaz, Moton, Zader, and Scott. Falquette was Acting Mayor during this meeting.

There being no objections, the reading of the Journal and Correspondence was dispensed with.

PUBLIC COMMENTS:

PRESIDENT FALQUETTE: And do we have anyone on the signup sheet. No one tonight. Alright, we'll move right up forward. Committee reports? Mr. Mayor?

MAYOR THEAKER: No Mr. President, I have nothing.

PRESIDENT FALQUETTE: Mr. Safety Service Director/Public Works Director?

DIRECTOR REMY: Nothing, sir.

PRESIDENT FALQUETTE: And Assistant Law Director?

JOHN SPON: No thank you.

END OF DISCUSSION

PRESIDENT FALQUETTE: Thank you gentlemen. Alright, proceed with legislation. Mrs. Burns do we have any late bills?

CHERYL MEIER: You asked about committee reports.

PRESIDENT FALQUETTE: I did a while back.

CHERYL MEIER: I know. I'm sorry, I was napping. I wanted to let everyone know that the corner planter at Lexington Avenue and Cook Road has been cleaned out today in preparation of replanting in the spring. And I have taken that on and will get some volunteers to plant that in the spring. But it looks 100 times better.

PRESIDENT FALQUETTE: Thank you for taking care of that. Appreciate that. In the interest, I was at the bike trail extension thing. I have drawings and pictures if anybody wants to see them after the meeting. Alright, lets move on. Mrs. Burns back to you for late bills, yes no?
