Now I'm shooting myself in the foot on this one because I'd have to pay it. Because its usually the neighborhoods and the citizens that use the parks in their neighborhoods. Where my concerns or my thoughts might be that with what were doing here, adding this extra .25 % on a payroll tax. I appreciate the people in Lexington and Ontario, outside the city limits paying for parks, but I know I've gotten into some arguments in the past about this representation and taxation and all this other stuff. I'm just kinda wondering if there was any kind of consideration by the administration given, maybe on millage instead of going with the .25% payroll. Just a thought. I'm not really throwing it out there as conversation or debate or an argument. I'm just wondering if there was any consideration for that. Thank you.


