

**REGULAR COUNCIL MEETING**  
**April 4, 2023**

The first monthly meeting of Mansfield City Council met on  
Tuesday April 4, 2023 at 7:35 pm in the  
Council Chambers of the City Building.

The Pledge of Allegiance was recited by the audience.

Eleazer Akuchie led the audience in prayer.

**ROLL CALL:** The following answered present at roll call: Burns, Meier (excused 7-0), Akuchie, Davenport, Diaz, Moton, Zader, Scott, and Falquette.

There being no objections, the reading of the Journal and Correspondence was dispensed with.

**PUBLIC COMMENTS:**

**PRESIDENT FALQUETTE:** Alright. Let's do speaking before council. We have Roberta Skok. I hope I'm close. Come on up Roberta and you get to repronounce your name and address correctly. And we have 3-minute limits on our timing of public comments, so you can go ahead. Thank you.

**ROBERTA SKOK:** My name is Roberta Skok. I'm the regional director of AFSCME in Ohio Council 8. Our office is in Worthington. Office address is 6800 North High Street. Personal address is 775 TWP Rd. 2204 Perrysville. So, I'm from up here. I want to thank you all for allowing me to speak and introduce myself to some of those I hadn't had a chance to introduce myself to. So, the reason I'm here tonight is the ongoing issue with AFSCME's "Me-Too" clause. During the last set of negotiations, the union put a "Me-Too" clause in the current collective bargaining agreement. And it states that in the event that any other unit with the City of Mansfield receives greater wage benefits AFSCME Local 3088 will receive the same benefits effective on the same date as the other bargaining unit. As we've heard tonight F.O.P. and OC...or O.L.C. was approved. They received 12.75 across the three years. They got 7.75. 2.5, 2.5 for the three years. And it was retro back to 3/11 of 22. (3/11/22) along with a lump sum of \$6,500.00. IAFF received wage increases 4, 4, 4 percent for a total of 12% over the three years. And the non-bargaining unit here with the City just received...just recently received the \$4,000 lump sum. AFSCME received 3%. 2.75%, 2.75%, for a total of 8.5 over the three years. So, we have been working labor and management through some settlement talks. And they've been going on now for over a year or right at the year. To date we don't have an agreement. We have filed a request for arbitration. So, we are moving forward to arbitration. The Union is requesting 4.25% plus the \$6,500 bonus, the same as the F.O.P. and the O.L.C. AFSCME was the only one that had the "Me-Too" clause, yet the city has no settlement for us. The cost of moving this forward for arbitration is going to cost thousands of dollars by the time you pay for attorney fees and arbitrator fees. So, we're asking tonight that City Council, the Mayor, Safety Service Director, HR Director, Public Works Director, all those that are involved grant our grievance and don't waste the taxpayer's money on attorney fees and arbitration fees. So, I just want you guys to consider that. A city employee is a city employee. Doesn't matter if you're City of Police, Fire, or collecting payments or working in the Street Department. We all need to be treated the same. So, that's the end for now thank you.

**PRESIDENT FALQUETTE:** Thank you I appreciate that. Alright. Mr. Tasiff. Mr. Tasiff has agreed to the three-minute window as well. (laughter)

**LEE TASIFF:** Probably the only bad thing I had planned was the tallest guy in the room I had to get around to get up here. Thank you for giving me a couple minutes to do this. I'm formally presenting our brand-new Visitor Guide for 2023 to you. It's up eight pages from last year. We went from 52 to 60 and believe it or not we obviously we don't have a shortage of things to put in this guide. But we actually have a hard time narrowing things down to fit it into a 60-page guide. Our job is to present the community in the best possible light for people that want to come visit here. While we have their attention, we also built in some profiles into the guide. And this year we featured Louie Andres who is from southwest Ohio, he came up to manage Malabar Farm State Park for 16 years back in the 90's. He stayed here. Built his family here. Built a house here. He's a good story on a good place to live and work. Again, while we have their attention we tell them other stories. We also feature Nikia Fletcher with Mansfield City Schools. She's from here. She left, she came back. She always knew she wanted to raise her family here and her family is featured in there. And also, Carmen and Duncan McFarland with Phoenix. So, neither was from here. I think Duncan might have been here when he was two but that doesn't really count. But all of them have a story to tell of they either came back or they came here and found great reasons to stick around and build their life and their careers. When I talk about putting our image out there we work off of authenticity. Everyone you see in this guide is a picture that we took is from people here in the community. Last year we featured over 100 different local models. So, please look through it. Find people that you like, keep them, get their autograph, do what you want with them. On the cover we feature the Buckeye Imagination Museum. It's their year to be featured. The kids, the two brothers that are coming down the slide and it's meant to look like they're flying off of the slide at everybody. But their family owns the Dairyland up on 39 near 30. So, again, local. They had fun at the Museum. We took a bunch of fun pictures of kids in there. And that translates to a lot of the energy that you get when you...when...and the fun the kids have when they go to the museum. So, beyond the photos that we took, you see a lot of them in here that we took last year. We also took a lot of videos. Which I reported on at the end of last year. You want to see those this is shameless plug to come to our annual meeting in 6 weeks. She'll be getting the invitation shortly. Then you can see the six videos that we produced and also how we're going to use them in digital campaigns throughout the year. If I've hit my limit, I'm done. Thank you very much. Any questions before?

**PRESIDENT FALQUETTE:** Any questions?

**AMY YOCKEY:** Nicely done.

**PRESIDENT FALQUETTE:** Hey uh...

**AURELIO DIAZ:** I have a comment. I'm drawn to page 18. It's very stunning, so yea. What a nice model there. No but seriously, these are like in it though juice glasses to me. Every year it's like there collectible items to kinda see ya know the representation of our community. I love seeing people that we know. Like Mrs. Fletcher, and business owners and workmanship. But also, it's just a huge resource for ya know no one could ever say there's nothing to do in Richland County. And I love that it highlights our new branding that you and Ms. Perry and a few people have been responsible for doing so...good job.

**LEE TASIFF:** Yea. And also, we distribute these regionally. We distribute them around the state and also one of our partners to distribute is with the Mansfield Richland County Public Library system. They've been a partner for a number of years so there distributed throughout the branches as well. And yes, your right. This is the second generation built from the brand.

**PRESIDENT FALQUETTE:** Thank you sir, can you push the button on your...thank you. Appreciate it. Alright, that takes care of public comment. Committee reports, do we have any committee reports? Umm...hang on. Would the Mayor like to address Council?

**MAYOR THEAKER:** No, Mr. President, I have nothing.

**PRESIDENT FALQUETTE:** Mr. Remy?

**DIRECTOR REMY:** Nothing, sir.

**PRESIDENT FALQUETTE:** Mr. Brown?

**CHRIS BROWN:** No thank you sir.

END OF DISCUSSION

**PRESIDENT FALQUETTE:** Alright were going to proceed with legislation. Mrs. Burns do you have any late bills this evening?

### **SUSPEND RULES**

**LAURA BURNS:** We do not. Therefore, I would like to move with respect to all bills that come before council this evening that the rule requiring reading on three different days be suspended and that each bill be read one time by title only. Seconded by Mrs. Zader. The vote was taken and resulted as follows:

**PRESIDENT FALQUETTE:** Alright anything else Mrs. Burns? Suspension, late bills, your all set. Alright, wonderful. Now Ms. Moton, were going to call on Ms. Moton because she has a motion to make at this point.

**KIM MOTON:** Yes, thank you so much Mr. President. I'd like to make a motion to go into executive session to discuss collective bargaining matters and for Mrs. May to be allowed into the executive session.

**PRESIDENT FALQUETTE:** Alright, it's been moved and seconded were going to go into executive session to discuss collective bargaining. All those in favor please cast your vote on the software before you leave Mr. Scott.

**COUNCIL MEMBERS:** We already voted.

**PRESIDENT FALQUETTE:** Ok, passes 7 to 0.

**ALL OF COUNCIL WENT INTO EXECUTIVE SESSION, INCLUDING THE MAYOR, DAVE REMY, CHRIS BROWN, AND SHARON MAY. *Session lasted 26 minutes.***

**PRESIDENT FALQUETTE:** Ms. Moton would you like to make a motion?

**KIM MOTON:** Yes, a motion to come back from executive session.

**AURELIO DIAZ:** Second.

**PRESIDENT FALQUETTE:** It's been moved and seconded we come out of executive session. Let's vote on that. Passes 7-0. Alright were back to regular business. Mr. Davenport 23-030 second reading.

**ALOMAR DAVENPORT:** Thank you Mr. President I move that bill 23-030 be read and placed upon the floor for discussion.

**STEPHANIE ZADER:** Second.


