# REGULAR COUNCIL MEETING April 18, 2023

The second monthly meeting of Mansfield City Council met on Tuesday April 18, 2023 at 7:04 pm in the Council Chambers of the City Building.

The Pledge of Allegiance was recited by the audience.

Eleazer Akuchie led the audience in prayer.

**ROLL CALL**: The following answered present at roll call: Burns, Meier, Akuchie, Davenport, Diaz, Moton, Zader, Scott, and Falquette.

There being no objections, the reading of the Journal and Correspondence was dispensed with.

#### **PUBLIC COMMENTS:**

**PRESIDENT FALQUETTE:** We have one person, Deborah Mount, to address Council this evening. If she would come forward, state her name and address. Three minutes maximum.

**DEBORAH MOUNT:** Deborah Mount, 114 Cliffbrook Drive. Coming today with a concern about the water bill I received today, and I contacted a few of you and got some answers throughout the day. Throughout the time the water rates were being discussed it sounded like what was settled on was an increase of approximately 30% with approximately 3% raises every year after that. My bill went up 60%. So, I was pretty shocked and just hoping that the City will address that, give some answers to other people. Specifically, I'm thinking elderly people that don't use a lot of water are likely to be in the boat. I understand it is the readiness to serve charge, but it wasn't accurately portrayed to the residents. If the 60% increase is what apparently is happening. So, I'm just hoping that the city will improve communications on the substantial increase. Thank you.
