# REGULAR COUNCIL MEETING January 2, 2024

The first monthly meeting of Mansfield City Council met on Tuesday, January 2, 2024 at 7:06 pm in the Council Chambers of the City Building.

The Pledge of Allegiance was recited by the audience.

Eleazer Akuchie led the audience in prayer.

CHIEF KEITH PORCH: So, for similar, for -001 and -002 are the same are the same type of actions, for Then & Now, so the first one is a language is a software for Metrich Enforcement Unit. We had grant funds to secure that payment. Uh, we originally, uh, cause we went to a new service of a year, to new grants, those service states did not match up between those several grants, which caused the lag, and then caused the Then & Now. We always had the funds available for the, uh, that renewed service of PenLink, and it's the exact similar situation for -002.
