**MEMORANDUM OF UNDERSTANDING
BETWEEN
THE 179TH SECURITY FORCES SQUADRON
AND
THE MANSFIELD POLICE DEPARTMENT
FOR
LAW ENFORCEMENT RESPONSE ASSISTANCE AND INFORMATION SHARING**

This is a memorandum of understanding (MOU) between the 179th Security Forces Squadron (179 SFS), Mansfield Lahm Air National Guard Base, OH (Mansfield Lahm ANGB), and the Mansfield Police Department (Mansfield Police Department). When referred to collectively, the 179 SFS and the Mansfield Police Department are referred to as the "Parties."

1. **BACKGROUND:** In accordance with (IAW) Air Force Instruction (AFI) 31-115, *Law and Order Operations*, 18 August 2020, paragraph 9.3.4, MOUs will be made between military and civilian authorities to expedite assistance and define guidelines to be used.
2. **PURPOSE:** This MOU outlines cooperation between the parties. This MOU is intended to formalize the provision of response assistance and the sharing of information concerning known or potentially known criminal or terrorist activities against Mansfield Lahm ANGB, OH and the surrounding communities that border the installation. This MOU outlines responsibilities required to support criminal history and National Instant Criminal Background Check System (NICS) indexing.
3. **AUTHORITIES:** DoDI 4000.19, *Support Agreements*, and DoDI 5200.08, *Security of DoD Installations and Resources and the DoD Physical Security Review Board (PSRB)*.
4. **REFERENCES:** DAFI 31-101, *Integrated Defense*, AFI 31-115, *Law and Order Operations*, AFMAN 71-102, *Air Force Criminal Indexing*, and Mansfield ANGB, OH Integrated Defense Plan.
5. **UNDERSTANDINGS OF THE PARTIES:**
 - 5.1. **SCOPE:** This MOU does not create additional jurisdiction or limit or modify existing jurisdiction vested in the parties. This MOU is only intended to provide guidance and document an agreement for general support between the parties.
 - 5.1.1. **AGREEMENT AND ADMINISTRATION:** This MOU provides documentation for support between the parties to outline response procedures for the installation and surrounding communities. If either party requests termination of this agreement, it will be terminated 30 days after that party provides written notification of termination to the other party. This MOU will be updated or revised as needed. At a minimum, this MOU will be reviewed annually by both parties on or before the anniversary effective date of the original agreement.
 - 5.1.2. The parties will determine the frequency of coordination, but it is recommended the parties meet quarterly to review current trends and to discuss matters related to this agreement or to provide familiarization between units. The 179 SFS is the lead to

coordinate and document the quarterly meetings, and invite relevant installation stakeholders.

5.1.3. The 79 SFS at Mansfield Lahm ANGB is within the jurisdictional footprint of Mansfield Police Department. Mansfield Lahm ANGB is a single installation and the sharing of certain information between Mansfield Lahm ANGB and Mansfield Police Department is essential for establishing a common operating picture of known or potential criminal or terrorist activities affecting the installation.

5.2. LIABILITY: The Parties agree that each Party is responsible for the negligent and wrongful acts and omissions by its employees or its members. In addition, the Parties agree that should a claim arise under the terms and conditions of the Federal Tort Claims Act (FTCA), Title 28, United States Code Section 1346 and 2671, et.seq., or applicable state law for the negligent and wrongful act or omission by the 179 SFS or the Mansfield Police Department, the Party in question will utilize their appropriate claims and investigative channels. Nothing in this paragraph prevents any party from conducting an independent administrative review of the incident giving rise to the claim; however final disposition of any claims arising out of this MOU will be handled by the Parties respective organizational claims structures. Both Parties agree to cooperate fully with one another in the event on an official investigation arising from alleged negligence or misconduct arising from acts related to the Mansfield Police Department providing the services contemplated under this MOU. The Parties shall be responsible for the loss or damage of any equipment or personal property belonging to them, for any reason or under any circumstances. Nothing herein should be construed as an assumption by either party in advance of liability.

5.3. RESPONSIBILITIES:

5.3.1. FINANCIAL MANAGEMENT:

5.3.1.1. 179 SFS will not expend any additional funds in support of this MOU.

5.3.1.2. Mansfield Police Department will not expend any additional funds in support of this MOU.

5.3.2. LOGISTICAL SUPPORT:

5.3.2.1. PLANS: There will be no additional plans to accompany this MOU.

5.3.3. MAINTENANCE: All agencies will be responsible for maintenance of their equipment.

5.3.4. SUPPLY: All agencies will be responsible for any supplies they may require.

5.3.5. TRANSPORTATION: All agencies will be responsible for their own transportation.

5.3.6. CONTRACTING: There will be no contracting support required for this MOU.

5.4. OPERATIONAL SUPPORT:

- 5.4.1.** Mansfield Police Department, may be requested to provide law enforcement assistance for a crowd confrontation team, civil disturbances, law enforcement emergencies, large protest demonstrations, aircraft disasters, boating or watercraft disasters, fires, hurricanes, tornadoes or other weather related crisis, sporting events, concerts, parades, escapes from detention facilities, traffic control need associated with contingency operations and incidents requiring utilization of specialized units capable of responding within two hours to assist with public disturbances beyond control of 179 SFS.
- 5.4.2.** Mansfield Police Department, agrees to notify 179 SFS, whenever information of a criminal nature or of intelligence value is developed that could affect any mission or personnel within Mansfield Lahm ANGB, OH. 179 SFS agrees to protect information received from Mansfield Police Department, in accordance with established Department of Defense (DoD) policy and guidance, or as required by Mansfield Police Department policy and guidance, to prevent the compromise of ongoing investigations or operations.
- 5.4.3.** Mansfield Police Department will aid the 179 SFS, upon request, by deploying patrols or other available Mansfield Police Department assets as deemed appropriate, during situations requiring immediate law enforcement support (such as active shooters, domestic violence, hostage negotiators or other situations where loss of life is imminent), aiding in criminal investigations, assisting in traffic control, and sharing information.
- 5.4.4.** Mansfield Police Department, agrees to cooperate with and share information to facilitate fulfillment of criminal indexing requirements, even when they assume lead agency or accept an investigative referral from Mansfield Lahm ANGB. The parties agree that 179 SFS must still collect required information for 179 SFS to accomplish NICS indexing, if one of the prohibitions are met in accordance with Title 18 United States Code Section 922, *Unlawful Acts* (also cited as the *Brady Handgun Violence Prevention Act of 1993, or Brady Act*) and Air Force Manual (AFMAN) 71-102. Mansfield Police Department agrees to collect fingerprints and/or DNA on behalf of the 179 SFS to accomplish NICS indexing.
- 5.4.5.** Mansfield Police Department will provide the 179 AW with support in the processing of Ohio LEADS (Law Enforcement Automated Data System) terminal access using the 179 SFS ORI as the originating agency. The 179 SFS has a non-terminal agreement with LEADS and only requires a terminal agency such as the Mansfield Police Department when necessary.
- 5.4.6.** Mansfield Police Department agrees to share with the 179 SFS, information on investigations originating on the installation (Mansfield ANGB, OH). This could also include court information regarding the disposition of said investigations.
- 5.4.7.** Mansfield Police Department agrees to support 179 SFS, upon request, with traffic and crowd control support in areas immediately adjacent to the installation during

events such as Air Shows, the 4th of July, or other events which could have an impact on city traffic flow.

- 5.4.8. The parties agree to share information relative to Community Policing and Crime Prevention.
 - 5.4.9. 179 SFS agrees to support Mansfield Police Department, with Security Forces patrol escorts when serving warrants and subpoenas within Mansfield ANGB, OH, and will follow 179th Airlift Wing (179 AW) policy and guidance in doing so.
 - 5.4.10. 179 SFS agrees to provide Mansfield Police Department, with training support such as instructors, facilities, and materials consistent with Air Force and Mansfield Police Department policy and guidance. Training will be coordinated and agreed upon in advance by all parties involved. Installation mission requirements will take precedence over all other training.
 - 5.4.11. 179 SFS agrees to appoint a Security Forces representative from the S2 Intelligence, Investigations, and Analysis; and SSL Police Services functions. Representatives will liaise with Mansfield Police Department, consistent with the operational support of MOU.
 - 5.4.12. 179 SFS agrees to invite Mansfield Police Department to participate in active shooter and other emergency response exercises.
- 5.5. COMMAND AND CONTROL:**
- 5.5.1. The parties responding assets agree to be organized under the Incident Command System as a Unified Command.
 - 5.5.2. The 179 AW will maintain Incident Command and overall management responsibility for all incidents on Mansfield Lahm ANGB, OH with the 179 AW Incident Commander (IC) having command and control of the incident and all first responders to ensure common goals and objectives, joint planning, integrated tactical operations, and maximization of all resources under a Unified Command response structure.
 - 5.5.3. Mansfield Police Department agrees, when providing personnel to support an incident within Mansfield Lahm ANGB, OH, to provide a representative to assist the 179 AW IC at the Incident Command Post. The representative will serve as the Liaison Officer between the parties and between Mansfield Police Department and the 179 AW IC. The Liaison Officer will inform the 179 AW IC of the capabilities and/or limitations of all assisting and responding Mansfield Police Department resources.
 - 5.5.4. Direct supervision and management of responding Mansfield Police Department resources will remain with Mansfield Police Department in accordance with departmental structure and/or policies.

6. **PERSONNEL:** Each Party is responsible for all costs of its personnel, including pay and benefits, support, and travel. Each Party is responsible for supervision and management of its personnel.
7. **POINTS OF CONTACT (POCs) AND CORRESPONDENCE:** The following POCs will be used by the Parties to communicate matters concerning this MOU. Each Party may change its POC upon reasonable notice to the other Party. All correspondence to be sent and notices to be given pursuant to this MOU will be addressed to the respective POCs for each Party.

8. **FUNDS AND MANPOWER:** This MOU neither documents nor provides for the exchange of funds or manpower between the Parties, nor does it make any commitment of funds or resources. No provision in this MOU will be interpreted to require obligation or payment of funds.
9. **MODIFICATION OF MOU:** This MOU may only be modified by the written agreement of the Parties, duly signed by their authorized representatives. This MOU will be reviewed no less often than at the mid-point of its term and around the anniversary of its effective date in its entirety.
10. **EFFECTIVE DATE:** This MOU takes effect beginning on the day after the last party signs.
11. **DISPUTES:** Any disputes relating to this MOU will, subject to any applicable law, Executive order, directive, or instruction, be resolved by consultation between the Parties.
12. **TERMINATION OF UNDERSTANDING:** This MOU may be terminated in writing at will by either Party.
13. **TRANSFERABILITY:** This MOU is not transferable except with the written consent of the Parties.
14. **ENTIRE UNDERSTANDING:** It is expressly understood and agreed that this MOU embodies the entire understanding between the Parties regarding the MOU's subject matter, thereby superseding all prior understandings of the Parties with respect to such subject matter.

15. CANCELLATION OF PREVIOUS MOU: This MOU cancels and supersedes the previously signed MOU between the same parties with the effective date of 14 February 2013.

16. EXPIRATION DATE: This MOU expires nine years from the effective date.

17. NO THIRD PARTY BENEFICIARIES: Nothing in this MOU, express or implied, is intended to give to, or will be construed to confer upon, any person not a party any remedy or claim under or by reason of this MOU and this MOU will be for the sole and exclusive benefit of the Parties.
