# REGULAR COUNCIL MEETING July 18, 2023

The first monthly meeting of Mansfield City Council met on Tuesday July 18, 2023 at 8:07 pm in the Council Chambers of the City Building.

The Pledge of Allegiance was recited by the audience.

Eleazer Akuchie led the audience in prayer.

**ROLL CALL**: The following answered present at roll call: Burns, Meier, Akuchie, Davenport, Diaz, Moton, Zader, Scott, and Falquette.

There being no objections, the reading of the Journal and Correspondence was dispensed with.

### **PUBLIC COMMENTS:**

**PRESIDENT FALQUETTE:** All right. And we have public comment. Public comment this evening. We'll start with Gary Minion. Public comments, three-minute maximum. We're asking you to make your statements and it's not a debate, not question and answer or anything, just coming on. And we appreciate that. If you state your name and your address. And go ahead.

**EASTHER MCNEIL:** I can't ask any question?

PRESIDENT FALQUETTE: You can say whatever you want.

**EASTHER MCNEIL:** Ok, well this is going to be short because I've been here for long enough. I got a bunch of stuff I put down, but I'm not going through all of it. I would like to know from the Street Department, is the City having work done on East Arch and Jeanette?

**PRESIDENT FALQUETTE:** This is where your probably not gonna get any answers because we're just getting the questions tonight. So hopefully somebody will take note and get back to you.

**EASTHER MCNEIL:** Ok. How many people, how many people do the City have that cut grass. Do they have any?

**PRESIDENT FALQUETTE:** Again Mr. McNeil, nobody here probably has that answer immediately. But somebody could look into it for you.

**EASTHER MCNEIL:** Ok. Well whoever's on the City Street Department.

PRESIDENT FALQUETTE: After the meeting the lady in the back row might know the answer.

**EASTHER MCNEIL:** I don't want to be up here all night. So, if you can't answer that, you're not going to answer the next one. Mr. Spon, I'm glad to see ya. I haven't seen ya in a long time.

(Law Director Spon and Stephanie Zader are talking without the mics on and you can barely hear them.)

**PRESIDENT FALQUETTE:** We're cutting into his 3 minutes.

EASTHER MCNEIL: Right. I wish she'd shut up.

PRESIDENT FALQUETTE: That's out of order Mr. McNeil.

**EASTHER MCNEIL:** It's out of order.

**PRESIDENT FALQUETTE:** Mr. McNeil, Mr. McNeil, I think your done for the night. Thank you. David Krist. I hope I said that right. If not there's a button in the middle of the microphone stand if you can press that.

**DAVID KIRST:** Thank you. Last name...

PRESIDENT FALQUETTE: State your name and address.

**DAVID KIRST:** Sure

PRESIDENT FALQUETTE: Three minutes sir.

**DAVID KIRST:** Good afternoon or evening I should say Council people. My name is David Kirst. My Address is 201 E 5<sup>th</sup> St here in Mansfield Ohio. I am the owner of a food truck, the newest one here in Mansfield Ohio. It is called The Chicken Box and it's been in operation now for just under 3 months. After reading this piece of legislation I can see how us small business owners, the smallest of business owners, would be affected in many negative ways. Let alone a thousand of Mansfielders that patronize such food venders as us. The fee of \$180 for a license plus an additional \$250 fee for a right-a-way license, plus a \$50 application fee is a grand total of \$480. This would be a financial hardship because these fees would then be added to the Health Department fees and the vendors license fees that already exist for us to operate. To get the Fire Department involved this would most like result in making us food truck owners install a fire depression system that could cost in the range of \$6 to \$10,000 that would decimate pretty much everyone in the food industry when it comes to mobile businesses.

# PRESIDENT FALQUETTE: Thank you David. And Tonia Keeler

TONIA KEELER: My names Tonia Keeler and I live at 68 1/2 Sturges Ave. I would like you guys to put the lights back in in the intersection of West First Street and Sturgis. I've lived on this street for 6 years now and I'm really, really really getting sick of the accidents. There's been 7 accidents, 7 of them. Three of them really serious. And because they think that Sturges now is a drag strip. They start from one end and step on it, fly! I've got video of cars flying down the street. One gentleman was in his new Mustang, hit the woman took her, twirled her around took her into my neighbors' yard. And my neighbors got cancer, could you imagine how she's feelings? A car come flying up into her yard and almost took out the gas pole that's in her yard. Could you imagine what was going to happen if that gas pole was taken out? 7 accidents in the last 6 years. Three within two months, two months. You guys can look it up in your traffic. It's horrifying, I have PTSD. And when I hear this, it hurts my chest. It hurts my heart. And I run out there because I was an STNA for 6 years and I have first aid. So, I run out there to help these people and I find this one gentleman laying on the ground and I thought he was dead. He wouldn't answer me at first. Ya know, and I'm constantly having to run out to help these people. And it's because people are running the stop sign on West First and coming out. Please put the light back. Please. People aren't getting it. When the light was there, there were no accidents. And now we have accidents of people getting hurt really bad and it's tearing me up and I can't take it. I don't know how anybody could take it. When you go out there and you find a man laying in the street out of his car, seriously what do you think and feel? Close your eyes and think if that was your family member laying on the ground like that. And it's because people are running that stop sign on West First Street. It really needs to be put back in. And I

beg you please think about this. It's too much. I'm not the only one that has been coming out to help. The last accident was not even a week and a half ago. And I asked the lady "Were you wearing your seatbelt?" Because I always ask them, if they did I tell them to go home and take a warm bath and get some Tylenol in them because of the impact. She said "No, I never wear my seatbelt." Isn't she....

PRESIDENT FALQUETTE: Ms. Keeler if you could wrap up.

TONIA KEELER: Alright, I'm done. Thank you.
