REGULAR COUNCIL MEETING August 1, 2023

The first monthly meeting of Mansfield City Council met on Tuesday August 1, 2023 at 7:26 pm in the Council Chambers of the City Building.

The Pledge of Allegiance was recited by the audience.

Eleazer Akuchie led the audience in prayer.

ROLL CALL: The following answered present at roll call: Burns, Meier, Akuchie, Davenport, Diaz, Moton, Zader, Scott, and Falquette.

There being no objections, the reading of the Journal and Correspondence was dispensed with.

PUBLIC COMMENTS:

PRESIDENT FALQUETTE: Do we have anyone signed up for Council? No one else. Alright. Committee reports. Mr. Mayor?

PRESIDENT FALQUETTE: Alright, we'll proceed with legislation. Mrs. Burns do we have any late bills tonight?

LAURA BURNS: No sir, we do not.

LAURA BURNS: I would like to. PRESIDENT FALQUETTE: Mrs. Burns do we have anything else? That was so fast. Just seems like you should have one more thing. Alright, you're up first though. 23-107 first reading.
