REGULAR COUNCIL MEETING Sept 19, 2023

The second monthly meeting of Mansfield City Council met on Tuesday, September 19, 2023 at 7:05 pm in the Council Chambers of the City Building.

The Pledge of Allegiance was recited by the audience.

David Falquette led the audience in prayer.

ROLL CALL: The following answered were present at roll call: Burns, Meier, Akuchie (excused absence), Davenport, Diaz, Moton, Zader (excused absence), Scott, and Falquette.

There being no objections, the reading of the Journal and Correspondence was dispensed with.

PUBLIC COMMENTS:

PRESIDENT FALQUETTE: We'll now have public comment. And Easther McNeil you're up first.

EASTHER MCNEIL: Just a couple things. Uh, parks...John Todd Park. If I'm not mistaken, the grass and weeds couldn't be cut because of butterflies or something like that. Correct me if I'm wrong. The parks over here. The City can't do anything about it. But now at the top of the hill where the gentleman, Mr. Boyd, bought that property. Which I believe is connected to the other property down the hill. So now we want to put small storage units, or big storage units whatever. Ok, I'm against that. Next, we got the streets that's being paved...re-asphalted. The people that are paving the streets are leaving asphalt all over the streets. I think they should be the ones to clean it up, not the City. I mean you go down the street and your car, all that asphalt that's left in the street gets up under your car. That should be on them that's putting it down, have some sweeper behind them. It shouldn't be the City's responsibility to clean up after somebody's doing the job. You're paying them to do that job, they should clean it up. That's it for me. Goodnight. I got a lot to say, but I just aint got time to say it.

PRESIDENT FALQUETTE: Thank you Mr. McNeil, we'll see ya next time.

EASTHER MCNEIL: I pray to God I'm here.

PRESIDENT FALQUETTE: Alright. Kelly Roscoe. Kelly if you can state your name and your address. And we got 3 minutes.

KELLY ROSCOE: My name is Kelly Roscoe. I live at 338 Boston Avenue. And on September 1st I woke to my basement flooding. Went outside and noticed that both of my yards were flooding. My garage was completely flooded. Walked up the street and noticed that there was a water main break about 4 houses up from us. Called the City. They didn't come out till about 2 hours later to turn that off. In the meantime, the water is coming into now my living room and my kitchen. We have bills totaling over \$6,000 and that's just cleaning up the basement. That doesn't include any appliances, anything in our garage that was ruined. Lawn mowers, freezers, refrigerators. And I would like the City to help. And that's it.

PRESIDENT FALQUETTE: Ok. If you see Ms. Amy, the Clerk, she will provide you with some forms.

KELLY ROSCOE: Thank you so much.

PRESIDENT FALQUETTE: Certainly. Thank you, Ms. Roscoe.

END OF DISCUSSION

PRESIDENT FALQUETTE: Do we have any committee reports? Alright Mayor, would you like to

address Council?

MAYOR THEAKER: No Mr. President, I have nothing.

PRESIDENT FALQUETTE: Director Remy?

PUBLIC WORKS DIRECTOR REMY: I have nothing sir.

PRESIDENT FALQUETTE: Director Spon?

LAW DIRECTOR SPON: I have nothing.

PRESIDENT FALQUETTE: Alright, we'll proceed with legislation. Mr. Scott.

PHIL SCOTT: Mr. President I would move that Council goes in to executive session pertaining to matters at the airport, Mansfield Lahm Airport.

PRESIDENT FALQUETTE: Pending legal...litigation.

PHIL SCOTT: Pending legal legislation...pending legal matters.

PRESIDENT FALQUETTE: Thank you. Do I have a second Mrs. Burns?

LAURA BURNS: Second.

PRESIDENT FALQUETTE: Thank you. All those...we roll call this right?

AMY YOCKEY: Yea, and I've got it up to vote.

PRESIDENT FALQUETTE: Alright, we have it up to vote. Passes 6 to 0. Alright, we are going to excuse ourselves to the back room and we'll be back. Hopefully shortly.

In executive session for 20 minutes.

PRESIDENT FALQUETTE: Alright, that didn't take too long. And I apologize for our technical snafu. Mr. Scott can you bring us back?

PHIL SCOTT: I can do that. I will make a motion that City Council comes out of executive session at 7:33.

CHERYL MEIER: Second.

PRESIDENT FALQUETTE: It's been moved and seconded to come out of executive session and we're faster than Amy thought. Laura Burns?

LAURA BURNS: Yes

PRESIDENT FALQUETTE: Cheryl Meier?

CHERYL MEIER: Yes.

PRESIDENT FALQUETTE: Alomar Davenport?

ALOMAR DAVENPORT: Yes

AURELIO DIAZ: Yes

PRESIDENT FALQUETTE: Mr. Diaz, thank you. Ms. Moton?

KIMBERLY MOTON: Yes

PRESIDENT FALQUETTE: And Phil Scott?

PHIL SCOTT: Yes

PRESIDENT FALQUETTE: Alright, it's unanimous. Were out of executive session. Alright, Mrs. Burns, we'll now proceed with legislation. Do we have any late bills tonight?

LAURA BURNS: No sir we do not. However...

PRESIDENT FALQUETTE: Alright. However?

SUSPEND RULES

LAURA BURNS: I would like to move with respect to all bills that come before council this evening that the rule requiring reading on three different days be suspended and that each bill be read one time by title only.
