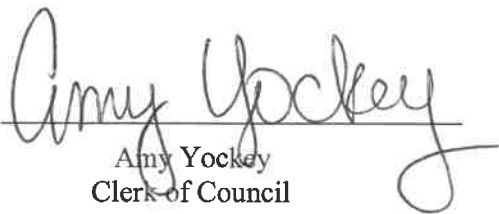
PRESIDENT FALQUETTE: It's been moved and seconded. All those in favor.

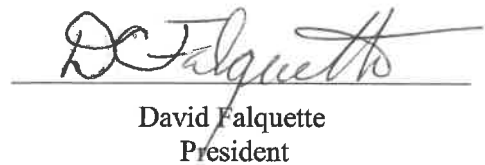
COUNCIL MEMBERS: Aye
