**March 20, 2024**

The second monthly meeting of Mansfield City Council met on  
Tuesday, March 20, 2024 at 8:04pm in the  
Council Chambers of the City Building.

The Pledge of Allegiance was recited by the audience.

Eleazer Akuchie led the audience in prayer.

**CHERYL MEIER:** I have one further question. What if we do not do this? What happens, how much money do we have at this point to, where would it leave the site? In what condition?

**MAYOR JODIE PERRY:** I think it would leave it about what it looks like now. Because, the money that the state has put in has gone towards where it sits now. I can't promise you that's exactly. The Land Bank is getting the billings in still, if there would be no back fill and the remaining excavation would not be completed.

**PRESIDENT SCOTT:** Mrs. Zader.

**STEPHANIE ZADER:** Follow up to that. So, you talked about the integrity of the structures further up the hill. Clearly, those sit up the hills, we leave a hole at the bottom and it rains, and that turns to mud, then we could look at potential liability as a city probably to those structures right, if we don't finish that and then something happens to those structures up the hill. Or, maybe that's a question more for the Law Director than the Mayor. Put you on the spot, Director Harper.

**DIRECTOR ROELIFF HARPER:** It seems pretty clear that could be the case.

**PRESIDENT SCOTT:** Mr. Falquette.

**DAVID FALQUETTE:** I think one other point that we can bring to council from caucus is the fact that when this was bid several years ago, this bidder was clearly lowest bidder by a lot. And sometimes this is what happens when you have a bidder that's off the charts low. And, he had done work for us in the past, he has done a lot of projects – I'm not gonna comment how good or bad those were cause I don't know. But this one had some short falls and it really is gonna remain, well if we wouldn't have done anything it would just be empty. It's a prime piece of real estate and I think the potential of getting this done, taken care of, and hopefully attracting a development of some sort on one of the busiest roads of Mansfield is where we should be headed. And, it hurts. But, I want to move it forward, get it done and move forward.

**STEPHANIE ZADER:** One last comment that I will make is you mentioned if we didn't do it. And one of the comments that was made on social media was if we could have re-done the building. And I don't think it was understood the magnitude of what that project would have looked like and it would have cost us far more than what it's going to cost us total even with going back and re-doing this project, to go through and re-do that. I don't know the exact cost, I didn't walk through the building, but I can tell you based on the size it would have cost us far more than what it's costing us to clean up that site.
