**GENERAL STATEMENT OF DUTIES:**

Under general supervision, functionally supervises assigned crew of Sewer Repair Division personnel in sewer construction, maintenance and repair. Performs related duties as required.

**EXAMPLES OF WORK (ILLUSTRATIVE ONLY):**

Functionally supervises assigned crew of Sewer Repair Division personnel; assists in assigning tasks and ensuring work complies with standards; assists in planning work schedules and projects; provides on-the-job training and instruction of assigned personnel; enforces personnel policies; issues oral and written warnings; may hear and resolve grievances.

Oversees and performs sewer construction, maintenance and repair;; supervises operation of and operates heavy equipment to perform tasks (e.g. graders, dozers, front end loaders, rollers, etc.); oversees and ensures work complies with established safety procedures; discusses job requirements with and receives and communicates detailed instructions from supervisors; makes and adjusts individual work assignments; requisitions necessary equipment and materials; prepares and maintains time and material and work records; notifies supervisor of emergencies.

**DESIRED KNOWLEDGE, SKILLS AND ABILITIES:**

Knowledge of (1) city and division policies and procedures, (2) safety practices and procedures, (3) sewer construction, maintenance and repair, (4) heavy equipment operation, (5) supervisory principles and practices, Skill in: (6) heavy equipment operation. Ability to: (7) carry out detailed written and oral instructions, (8) deal with problems involving several variables within familiar context; (9) read, copy and record figures accurately, (10) communicate effectively, (11) develop and maintain effective working relationships, (12) perform heavy manual labor for extended periods of time in often adverse conditions.

**ACCEPTABLE EXPERIENCE AND TRAINING:**

Completion of secondary education or equivalent and five years of progressively responsible experience in public works or related construction, maintenance and repair, or any equivalent combination of experience and training which provides the desired knowledge, skills and abilities.

**LICENSE/CERTIFICATION REQUIREMENTS:**

**Must possess an Ohio EPA Class II Waste Water Collection Operator certification or obtain such Certification within 6 months after being hired.**

**Must possess a Class B Commercial Drivers' License.**
