REGULAR COUNCIL MEETING July 16, 2024

The first monthly meeting of Mansfield City Council met on Tuesday, July 16, 2024 at **8:06pm** in the Council Chambers of the City Building.

The Pledge of Allegiance was recited by the audience. Eleazer Akuchie led the audience in prayer.

ROLL CALL: The following answered were present at roll call: Burns, Meier, Akuchie, Daley, Diaz, Mount, Zader, Falquette, and Scott.

There being no objections, the reading of the Journal and Correspondence was dispensed with.

PUBLIC COMMENTS

PRESIDENT SCOTT: I see our assistant clerk coming forward with the sign-up sheet, so there must be a few people that want to speak. One, ok. Thank you. Ok, Christian Lee.
